- 2 (H) (1) IF A HEARING IS HELD ON THE PROPOSED RULE OR AMENDMENT,
- 3 THE COMMISSION SHALL PUBLISH THE PLACE, TIME, AND DATE OF THE SCHEDULED
- 4 PUBLIC HEARING. IF THE HEARING IS HELD VIA ELECTRONIC MEANS, THE
- 5 COMMISSION SHALL PUBLISH THE MECHANISM FOR ACCESSING THE ELECTRONIC

 3 LICENSURE AGREEMENT OR OTHER COOPERATIVE ARRANGEMENT BETWEEN A

SECTION 13. CONSTRUCTION AND SEVERABILITY

10 THIS COMPACT SHALL BE LIBERALLY CONSTRUED SO AS TO EFFECTUATE THE PURPOSES THEREOF. THE PROVISIONS OF THIS COMPACT SHALL BE SEVERABLE 11 12 AND IF ANY PHRASE, CLAUSE, SENTENCE, OR PROVISION OF THIS COMPACT IS 13 DECLARED TO BE CONTRARY TO THE CONSTITUTION OF ANY MEMBER STATE OR OF THE UNITED STATES OR THE APPLICABILITY THEREOF TO ANY GOVERNMENT, 14 AGENCY, PERSON, OR CIRCUMSTANCE IS HELD INVALID, THE VALIDITY OF THE 15 REMAINDER OF THIS COMPACT AND THE APPLICABILITY THEREOF TO ANY 16 GOVERNMENT, AGENCY, PERSON, OR CIRCUMSTANCE SHALL NOT BE AFFECTED 17 18 THEREBY. IF THIS COMPACT SHALL BE HELD CONTRARY TO THE CONSTITUTION OF 19 ANY MEMBER STATE, THE COMPACT SHALL REMAIN IN FULL FORCE AND EFFECT AS 20 TO THE REMAINING MEMBER STATES AND IN FULL FORCE AND EFFECT AS TO THE 21MEMBER STATE AFFECTED AS TO ALL SEVERABLE MATTERS.

SECTION 14. BINDING EFFECT OF COMPACT AND OTHER LAWS

- 23 (A) NOTHING HEREIN PREVENTS THE ENFORCEMENT OF ANY OTHER LAW OF A MEMBER STATE THAT IS NOT INCONSISTENT WITH THE COMPACT.
- 25 (B) ALL LAWS IN A MEMBER STATE IN CONFLICT WITH THE COMPACT ARE 26 SUPERSEDED TO THE EXTENT OF THE CONFLICT.
- 27 (C) ALL LAWFUL ACTIONS OF THE COMMISSION, INCLUDING ALL RULES 28 AND BYLAWS PROMULGATED BY THE COMMISSION, ARE BINDING ON THE MEMBER 29 STATES.
- 30 **(D)** ALL AGREEMENTS BETWEEN THE COMMISSION AND THE MEMBER 31 STATES ARE BINDING IN ACCORDANCE WITH THEIR TERMS.
- 32 (E) IN THE EVENT ANY PROVISION OF THE COMPACT EXCEEDS THE 33 CONSTITUTIONAL LIMITS IMPOSED ON THE LEGISLATURE OF ANY MEMBER STATE, 34 THE PROVISION SHALL BE INEFFECTIVE TO THE EXTENT OF THE CONFLICT WITH

SECTION 2. AND BE IT FURTHER ENACTED, That this Act is contingent on the enacting of substantially similar legislation in nine other states. The Maryland Department of Health shall notify the Department of Legislative Services within 10 days after nine states have enacted legislation that is substantially similar to this Act.

6 SECTION 3. AND BE IT FURTHER ENACTED, That, subject to Section 2 of this 7 Act, this Act shall take effect October 1, 2021.
