## A BILL ENTITLED

1 AN ACT concerning

2 **State Board of Pharmacy – Pharmacy Closure – Notice to Customers**  
3 **(The Dennis Robin Act)**

4 FOR the purpose of requiring an owner of a pharmacy to post or mail a certain notice of a  
5 closing of the pharmacy within a certain period of time; requiring the notice to  
6 include certain information; requiring the State Board of Pharmacy to adopt certain  
7 regulations; and generally relating to the closing of a pharmacy.

8 BY adding to

10 Section 12–513

11 Annotated Code of Maryland

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
14 That the Laws of Maryland read as follows:

15 **Article – Health Occupations**

16 **12–513.**

17 **(A) BEFORE THE CLOSING OF A PHARMACY FOR MORE THAN 7**  
18 **CONSECUTIVE DAYS, THE OWNER OF THE PHARMACY SHALL PROVIDE NOTICE OF**  
19 **THE CLOSING BY:**

20 **(1) AT LEAST 30 DAYS BEFORE THE ANTICIPATED CLOSING OF THE**  
21 **PHARMACY, POSTING A NOTICE:**

22 **(I) THAT IS CONSPICUOUSLY POSITIONED IN THE PHARMACY**

1 AND READABLE BY PHARMACY CUSTOMERS; AND

2 (II) IF APPLICABLE, ON THE PHARMACY'S WEBSITE; OR

3 (2) AT LEAST 14 DAYS BEFORE THE ANTICIPATED CLOSING OF THE  
4 PHARMACY, MAILING A NOTICE TO EACH PHARMACY CUSTOMER THAT HAS A  
5 CURRENT AND AUTHORIZED REFILL OF A PRESCRIPTION ON FILE WITH THE  
6 PHARMACY.

7 (B) EACH NOTICE POSTED OR MAILED IN ACCORDANCE WITH SUBSECTION  
8 (A) OF THIS SECTION SHALL INDICATE:

9 (1) THE DATE OF THE ANTICIPATED CLOSING OF THE PHARMACY, IF  
10 AVAILABLE;

11 (2) THE NAME OF THE PHARMACY TO WHICH THE CLOSING  
12 PHARMACY WILL TRANSFER PHARMACY CUSTOMERS' PRESCRIPTIONS AND  
13 RECORDS; AND

14 (3) THAT A PHARMACY CUSTOMER MAY REQUEST THE CLOSING  
15 PHARMACY TO SEND THE PHARMACY CUSTOMER'S PRESCRIPTIONS AND RECORDS  
16 TO ANOTHER PHARMACY.

17 (C) THE BOARD SHALL ADOPT REGULATIONS TO:

18 (1) DEFINE "CLOSING OF A PHARMACY"; AND

19 (2) PROVIDE EXCEPTIONS TO THE REQUIREMENTS OF THIS SECTION.

20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
21 October 1, 2021.
