BY repealing and reenacting, with amendments, Article – Public Utilities Section 2–122, 7–211(k), and 7–512.1(c) and (d) Annotated Code of Maryland (2020 Replacement Volume and 2020 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - Public Utilities 2-122.On or before [the third Wednesday of March] MAY 1 of each year, the Commission shall publish an annual report that summarizes the activities of the Commission that includes:

4 5 6 7	(ii) The Office of Home Energy Programs may satisfy the reporting requirement of subparagraph (i)1 of this paragraph by providing the Commission with a copy of material that contains the required information and that the Office of Home Energy Programs submits to the federal government.
8 9 10	(iii) The Commission shall include the information provided by the Office of Home Energy Programs under subparagraph (i) of this paragraph in its report to the General Assembly under paragraph (1) of this subsection.
11 12 13 14	(3) Subject to subsection (d)(2) of this section, the Commission shall include the information provided by the Department of Housing and Community Development under subsection (d)(1) of this section in its report to the General Assembly under paragraph (1) of this subsection.
15 16 17	(4) The electric universal service program shall be subject to audit by the Office of Legislative Audits in accordance with §§ 2–1220 through 2–1227 of the State Government Article.
