- 3 That the Laws of Maryland read as follows:

- 6 (a) (1) The Secretary shall administer the Maryland Medical Assistance 7 Program.
- 8 (2) The Program:
- 9 (xv) Shall provide, subject to the limitations of the State budget, 10 mental health services appropriately delivered through telehealth to a patient in the 11 patient's home setting; [and]
- 12 (xvi) Beginning on January 1, 2021, shall provide, subject to the limitations of the State budget and § 15–855(b)(2) of the Insurance Article, and as permitted by federal law, services for pediatric autoimmune neuropsychiatric disorders associated with streptococcal infections and pediatric acute onset neuropsychiatric syndrome, including the use of intravenous immunoglobulin therapy, for eligible Program recipients, if pediatric autoimmune neuropsychiatric disorders associated with streptococcal infections and pediatric acute onset neuropsychiatric syndrome are coded for billing and diagnosis
- purposes in accordance with § 15–855(d) of the Insurance Article; AND
- 20 (XVII) BEGINNING ON JANUARY 1, 2022, MAY NOT INCLUDE, 21 SUBJECT TO FEDERAL APPROVAL AND LIMITATIONS OF THE STATE BUDGET, A
- 22 FREQUENCY LIMITATION ON COVERED DENTAL PROPHYLAXIS CARE OR ORAL
- 23 HEALTH EXAMS THAT REQUIRES THE DENTAL PROPHYLAXIS CARE OR ORAL HEALTH
