## 2 Anne Arundel County – Alcoholic Beverages – Class MT License

3 FOR the purpose of establishing a Class MT (movie theater) beer and wine license in Anne 4 Arundel County; authorizing the Board of License Commissioners for Anne Arundel  $\mathbf{5}$ County to issue the license to the owner of a movie theater who holds a certain 6 certification; authorizing a license holder to sell beer and wine to certain patrons at 7 retail at the place described in the license for on-premises consumption; specifying 8 the hours during which the license holder may sell beer and wine; specifying where 9 and how on the licensed premises beer and wine may be sold; specifying where on the licensed premises beer and wine may be consumed; specifying that a license 10 holder may serve a patron only a single serving of certain alcoholic beverages at a 11 12certain time; establishing a maximum number of servings of certain alcoholic beverages that may be provided to a patron per day; prohibiting a license holder from 1314allowing a patron to remove alcohol purchased at the movie theater from the licensed premises; stating that a license holder need not obtain a certain Sunday license; 1516 specifying that the license holder is subject to certain alcohol awareness 17requirements; establishing an annual license fee; providing that a holder of an 18 alcoholic beverages license for a movie theater may renew the license only as a Class 19MT (movie theater) beer and wine license; and generally relating to alcoholic 20beverages in Anne Arundel County.
