# National Capital Strategic Economic Development Program – Eligibility <u>and</u> <u>Funding</u>

- FOR the purpose of <u>extending certain funding to each fiscal year</u>; altering the definition of
  "national capital region" for the purposes of the National Capital Strategic Economic
  Development Program; requiring certain percentages of the National Capital
  Strategic Economic Development Fund to be used for community enhancement
  projects in sustainable communities located in certain areas in certain fiscal years;
  and generally relating to the National Capital Strategic Economic Development
