## 2 Community College Tuition and Residency Waivers Colleges and Private 3 Nonprofit Institutions of Higher Education – Funding

- 4 FOR the purpose of requiring the Governor, beginning in a certain fiscal year, to include in the annual State budget for the Maryland Higher Education Commission a General 5 6 Fund appropriation of a certain amount to fund certain community college tuition 7 and residency waivers; requiring the Commission to distribute the appropriation to each community college board of trustees based on the number of qualifying students 8 9 enrolled in each community college in proportion to the total number of qualifying 10 students, as determined by the Commission; requiring the Commission to adopt 11 certain regulations or guidelines; defining a certain term; requiring certain funding be provided to certain institutions of higher education in certain fiscal years; and 12 generally relating to community college funding for State-mandated tuition and 13 residency waivers and private nonprofit institutions of higher education funding. 14
