### 1 AN ACT concerning

# Procurement - Small Business Reserve Program - Administration and Application

4 FOR the purpose of providing that the Small Business Reserve Program applies to certain  $\mathbf{5}$ universities in the State; specifying certain guidelines that the Governor's Office of 6 Small, Minority, and Women Business Affairs is required to establish for the 7 administration of the Program; requiring that certain guidelines for the Program be 8 developed in partnership with certain persons; requiring that a unit assess certain 9 procurements up to and including a certain dollar value under the guidelines for the Program and either designate the procurement for the Program or request a certain 10 11 waiver certified by the Governor's Office of Small, Minority, and Women Business 12Affairs; making the provisions of this Act severable; and generally relating to the Small Business Reserve Program. 13

7 (a) Except as provided in subsection (d) of this section, this subtitle applies to all 8 procurements by a unit.

9 (b) This subsection does not apply to procurements subject to Subtitle 1 of this 10 title.

11 (c) To the extent practicable, a unit shall structure its procurement procedures to 12 achieve a minimum of 15% of the unit's total dollar value of goods, supplies, services, 13 maintenance, construction, construction–related services, and architectural and 14 engineering service contracts to be made directly to small businesses.

15 (d) The total dollar value of procurements by a unit does not include the value of 16 contracts to which this section does not apply because of a conflict with federal law.

17 (e) A unit may apply toward the unit's overall annual Small Business Reserve 18 payment achievement only those payments resulting from a procurement that is 19 designated a Small Business Reserve procurement.

(f) The Special Secretary for the Office of Small, Minority, and Women Business
 Affairs, in consultation with the Attorney General, shall establish standards and guidelines
 for participation in the Small Business Reserve Program every 5 years.
