2 Health Occupations – State Board of Massage Therapy Examiners – Revisions

3 FOR the purpose of altering a certain requirement for certain State Board of Massage 4 Therapy Examiners members who are licensed massage therapists; altering the $\mathbf{5}$ education requirements for applicants to qualify for a certain license or registration 6 by requiring that certain curriculums and programs be endorsed by a certain entity 7 or a certain equivalent entity; altering the number of sets of certain fingerprints that 8 certain applicants are required to submit to the Criminal Justice Information 9 System Central Repository of the Department of Public Safety and Correctional Services; requiring the Central Repository to provide the Board with a certain 1011 revised statement under certain circumstances; requiring the Board to consider 12certain information when making certain determinations about certain applicants; 13 requiring the Board to place certain licensed massage therapists and registered 14massage practitioners on inactive status under certain circumstances; authorizing 15certain licensed massage therapists and registered massage practitioners to 16reactivate the license or registration under certain circumstances; altering a certain 17ground for discipline; repealing a certain provision of law that provides that certain 18 provisions of law do not require certain persons to reimburse a licensed massage 19therapist or registered massage practitioner for certain services rendered; altering a 20certain definition; making technical changes; and generally relating to the regulation 21 of massage therapists and massage practitioners.

1 (1) **[Two] ONE** complete **[sets] SET** of legible fingerprints taken on **[forms]** 2 **A FORM** approved by the Director of the Central Repository and the Director of the Federal 3 Bureau of Investigation;

4 (2) The fee authorized under § 10–221(b)(7) of the Criminal Procedure 5 Article for access to State criminal history records; and

6 (3) The processing fee required by the Federal Bureau of Investigation for 7 a national criminal history records check.

11 (2) IF CRIMINAL HISTORY RECORD INFORMATION IS REPORTED TO 12 THE CENTRAL REPOSITORY AFTER THE DATE OF THE INITIAL CRIMINAL HISTORY 13 RECORDS CHECK, THE CENTRAL REPOSITORY SHALL PROVIDE TO THE BOARD A 14 REVISED PRINTED STATEMENT OF THE INDIVIDUAL'S STATE CRIMINAL HISTORY 15 RECORD.

(f) The subject of a criminal history records check under this section may contest
the contents of the printed statement issued by the Central Repository as provided in §

(G) IN USING INFORMATION OBTAINED FROM THE CENTRAL REPOSITORY UNDER THIS SECTION TO DETERMINE WHETHER TO ISSUE A LICENSE OR REGISTRATION, THE BOARD SHALL CONSIDER:

- 30 (1) THE AGE AT WHICH THE CRIME WAS COMMITTED;
