 $\mathbf{5}$ FOR the purpose of requiring the Executive Director of the Alcohol and Tobacco 6 Commission to be a sworn police officer with certain powers; specifying that the 7 Executive Director is a member of the Law Enforcement Officers' Pension System as 8 a condition of employment; providing that an individual who commences 9 employment as the Executive Director of the State Retirement Agency on or after a 10 certain date shall have immediate vesting rights in the Employees' Pension System; 11 requiring the Board of Trustees for the State Retirement and Pension System to 12 transfer certain service earned under certain circumstances; requiring the Board of 13Trustees to transfer certain employer and member contributions from the 14 Employees' Pension System to the Law Enforcement Officers' Pension System; 15requiring the State Retirement Agency to submit a certain report on or before a certain date on immediate vesting for certain positions; and generally relating to the 16 Executive Director of the Alcohol and Tobacco Commission membership and vesting 1718 in the State Retirement and Pension System for certain Executive Directors.

9 SECTION 3. <u>4.</u> AND BE IT FURTHER ENACTED, That this Act shall take effect 10 June 1, 2021.
