- 14 (a) There is a Workgroup on Adaptive Reuse of Vacant Commercial Spaces.
- 15 (b) The Workgroup consists of the following members:
- 16 (1) two members of the Senate of Maryland, appointed by the President of 17 the Senate:
- 18 (2) two members of the House of Delegates, appointed by the Speaker of 19 the House;
- 20 (3) the Secretary of Housing and Community Development, or the 21 Secretary's designee;
- 22 (4) the Secretary of Planning, or the Secretary's designee;
- 23 (5) one member of the Maryland Association of Counties;

2 3	(7) the following members, jointly appointed by the Presiding Officers of the General Assembly:

- 10 (g) On or before November 30, 2021, the Workgroup shall report its findings and 11 recommendations to the Governor and, in accordance with § 2–1257 of the State 12 Government Article, the General Assembly.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June 1, 2021. It shall remain effective for a period of 1 year and 1 month and, at the end of June 30, 2022, this Act, with no further action required by the General Assembly, shall be abrogated and of no further force and effect.
