## A BILL ENTITLED

1 AN ACT concerning

## Workgroup on the COVID–19 Crisis Economic Recovery

3 FOR the purpose of establishing the Workgroup on the COVID-19 Crisis Economic Recovery; providing for the composition, chair, and staffing of the Workgroup; 4  $\mathbf{5}$ prohibiting a member of the Workgroup from receiving certain compensation, but 6 authorizing the reimbursement of certain expenses; requiring the Workgroup to 7 study and make recommendations regarding certain matters; requiring the 8 Workgroup to submit an interim and final report to the Governor and the General 9 Assembly on or before certain dates; providing for the termination of this Act; and generally relating to the COVID-19 economic crisis. 10

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
That:

- 13 (a) There is a Workgroup on the COVID–19 Crisis Economic Recovery.
- 14 (b) The Workgroup consists of the following members:

15 (1) five members of the Senate of Maryland, including members from the 16 Budget and Taxation Committee, the Finance Committee, and the Education, Health, and 17 Environmental Affairs Committee, appointed by the President of the Senate;

18 (2) five members of the House of Delegates, including members from the 19 Appropriations Committee, the Committee on Ways and Means, the Economic Matters 20 Committee, the Health and Government Operations Committee, and the Environment and 21 Transportation Committee, appointed by the Speaker of the House;

- 22 (3) the Secretary of Commerce, or the Secretary's designee;

1 (i) On or before December 31, 2022, the Workgroup shall submit a final report of 2 its findings and recommendations to the Governor and, in accordance with § 2–1257 of the 3 State Government Article, the General Assembly.

4 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 5 1, 2021. It shall remain effective for a period of 2 years and, at the end of June 30, 2023, 6 this Act, with no further action required by the General Assembly, shall be abrogated and 7 of no further force and effect.
