Office of Legislative Audits – Acceptance and Investigation of Allegations of Fraud, Waste, and Abuse

FOR the purpose of authorizing the Office of Legislative Audits to compel by subpoena or otherwise certain records and the appearance of a person for a certain purpose: authorizing the Office to coordinate an investigation with certain law enforcement units; requiring certain law enforcement units to cooperate and share information under certain circumstances; providing that, except under certain circumstances, certain information obtained in relation to an act or allegation of fraud, waste, or abuse is confidential and may not be disclosed; authorizing the Legislative Auditor to authorize the disclosure of certain information in relation to an act or allegation of fraud, waste, or abuse to certain persons under certain circumstances; requiring the Office of Legislative Audits to maintain a certain fraud hotline; authorizing the Office to investigate or refer to a certain agency certain allegations under certain circumstances; requiring each unit of State government to keep posted in conspicuous places on its premises a certain notice and on its website a certain link, and distribute certain information to certain persons under certain circumstances, report certain information to the Office, and provide timely cooperation on certain inquiries; requiring the Office, in coordination with the Office of the Attorney General and the Office of the State Prosecutor, to evaluate and develop certain statutory and regulatory language; requiring the Office to report its findings to a certain committee of the General Assembly on or before a certain date; and generally relating to the Office of Legislative Audits.
