- WHEREAS, The enrollment of the State's nonpublic special education schools
- 14 consists primarily of public school students who are assigned to a nonpublic school due to
- their need for specialized services that cannot be offered by their local school system; and
- WHEREAS, During the 2020 Legislative Session, the General Assembly charged the
- 17 State Department of Education with reviewing compensation data and qualifications for
- 18 public and nonpublic school special education teachers and with identifying and analyzing
- 19 wage and compensation disparities between public and nonpublic school special education
- 20 teachers; and

| l | WHEREAS, The State Department of Education submitted its report to the General |

| 2 | Assembly on December 16, 2020, finding that salaries of nonpublic school special education |
| 3 | teachers were between 7.3% and 25% less than the salaries of similarly situated special |

WHEREAS, The State Department of Education also found that, when accounting for total paid hours, the wage disparity between similarly situated special education teachers in public schools and in nonpublic schools increased to between 23.3% and 40.7%; and

9 WHEREAS, Chapter 36 of the Acts of the General Assembly of 2021 will add \$4 billion in annual State and local spending above current spending projections by fiscal year 2030; and

WHEREAS, Chapter 36 of the Acts of the General Assembly of 2021 mandates minimum salary increases for certain accomplishments in amounts not more than \$17,000 annually for public school teachers beginning in fiscal year 2022; now, therefore,

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 16 That the Laws of Maryland read as follows:

- 19 (b) (1) A child with a disability who needs special education and related 20 services that cannot be provided in a public county, regional, or State program shall be 21 placed in an appropriate nonpublic educational program that offers these services.
- 22 (2) A child with a disability who needs special education and related 23 services is eligible for an appropriate nonpublic educational placement under this section 24 if a State or local agency provides documentation that the child cannot attend a public 25 school in the local school system:
 - (i) Because of the child's home circumstances; or
- 27 (ii) Subject to subsection (d)(1) and (2) of this section, because of 28 medical necessity.
- 29 (c) (1) The cost of the nonpublic educational program shall be paid by the State 30 and the county in which the child is domiciled in accordance with § 8–415(d) of this subtitle, 31 as appropriate.
- 32 (2) Subject to availability of funding in the State budget, for a child who qualifies for a nonpublic educational program under subsection (b)(2) of this section and who requires wraparound services in order to receive special education and related services

- 1 in the least restrictive environment, the cost of providing the services shall be paid by the

- 6 (d) In this subsection, "basic cost" as to each county, means the average (1) 7 amount spent by the county from county, State, and federal sources for the public education 8 of a nonhandicapped child. "Basic cost" does not include amounts specifically allocated and 9 spent for identifiable compensatory programs for disadvantaged children.
- 10 As provided in paragraphs (3) and (4) of this subsection, the State and 11 the counties shall share collectively in the cost of educating children with disabilities in 12 nonpublic programs under § 8–406 of this subtitle.
- 13 (3)Subject to the limitation under subparagraph (ii) of this 14 paragraph, for each of these children domiciled in the county, the county shall contribute 15 for each placement the sum of:
- 16 1. The local share of the basic cost;
- 17 2. An additional amount equal to 200 percent of the basic 18 cost; and
- 19 3. For fiscal year 2009, an additional amount equal to Α. 20 20 percent of the approved cost or reimbursement in excess of the sum of items 1 and 2 of 21this subparagraph; and
- 22В. For fiscal year 2010 and each subsequent fiscal year 23thereafter, an additional amount equal to 30 percent of the approved cost or reimbursement 24in excess of the sum of items 1 and 2 of this subparagraph.
- 25(ii) The amount that a county is required to contribute under 26 subparagraph (i) of this paragraph may not exceed the total cost or reimbursement amount 27 approved by the Department.
- 28 **(4)** For each of these children, the State shall contribute an amount equal 29 to the amount of the approved cost or reimbursement in excess of the amount the county is 30 required to contribute under paragraph (3) of this subsection.
- SECTION 2. AND BE IT FURTHER ENACTED, That for fiscal year 2023, in 31 32 addition to the State contribution required under § 8-415(d)(4) of the Education Article 33 shall include, the Governor shall include in the annual budget bill an appropriation from 34 the unexpended appropriation for Aid to Education, Nonpublic Placements Program (R00A02.07) within the Maryland State Department of Education that was included in the 36 fiscal year 2020 or 2021 operating budget to provide:
