10 Description and Purpose of Organization (Limit length to visible area)							

The Hampstead Volunteer Fire Company (HVFD), is a 501 C3 organization which has been the first line of emergency services (Fire, Rescue and EMS) for the Town of Hampstead and the surrounding communities of Carroll and Baltimore counties since 1900. The HVFD is comprised of ~ 100 volunteers and 20 paid personnel (combined full time and part-time), which operates out of single station on main street in Hampstead, MD. The station provides services with two paramedic equipped ambulances, one 100' Ladder Truck, two Pumper Engines, two Utility Vehicles, one Brush Unit and one Duty Vehicle. The HVFD is a central component of the community providing fire safety, training, and meeting facilities, social, and fund raising functions. The fire station is designated as a safe zone during emergencies. The LBI will provide alerting, video and security for facilities.

11. Description and Purpose of Project (Limit length to visible area)

The HVFD is replacing the current station with a new primary operations center for emergency services. This building will house all emergency vehicles, and contain offices, bunk rooms, training rooms, kitchen, and necessary storage and cleaning capabilities to keep equipment and turnout gear ready for service. The overall cost of the building project is \$ 5.8 million. The LBI request of \$ 175,000 is for an integrated alerting, security access, video monitoring system. The system includes: Integrated feed from Carroll 911 system, physical access controls to and within building, provides Dynamically generated map incident data on the LCD monitors placing a marker at the incident location. The map display Doppler Radar weather map, 24hr incident history, Hospital status, Equipment status, Upcoming events, Road Closures, Duty Schedules, and State Emergency Management Information

28. Comments

In any emergency or life threatening situation, time is a critical issue. Time to identify which emergency equipment is responsible, are they available, what is the location of the emergency, what is the best route of travel, are there other issues on the normal route of travel (road closures, flooding), etc. The alerting system defined in this request is directly integrated with the Carroll County 911 system and provides the fastest possible notification of the call. It is also identifies resources in the station, weather alerts, other units responding, other major incidents in the County which may impact the availability of resources. Updates from the State Emergency Management System are displayed, along with Doppler Radar. The access control system included in this solution ensures access to the facility, and all secure locations in the building (storage rooms, medical supplies, etc) with direct accountability and tracking of people. The security cameras and monitoring equipment ensures full coverage of the building perimeter, access points and secure locations with active monitoring and recorded images. The system is easily updated to ensure compatability with any changes associated with the 911 system.
