AMENDMENTS TO HOUSE BILL 107  
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in the sponsor line, strike “**Delegate Holmes**” and substitute “**Delegates Holmes, Foley, Healey, Lehman, and Terrasa**”.

AMENDMENT NO. 2

On page 10, in lines 12 and 17, strike “**2017**” and substitute “**2018**”; and in line 19, strike “**2022**” and substitute “**2023**”.

AMENDMENT NO. 3

On page 4 in line 5, on page 7 in line 20, and on page 10 in line 25, in each instance, after “(ii)” insert “**HAS PARTICIPATED IN THE PREPARATION OF AT LEAST 30 RESERVE STUDIES WITHIN THE PRIOR 3 CALENDAR YEARS WHILE EMPLOYED BY A FIRM THAT PREPARES RESERVE STUDIES**”.

On page 4, strike beginning with “Holds” in line 5 down through “education” in line 6.

On page 7, strike beginning with “Holds” in line 20 down through “education” in line 21.

On page 10, strike beginning with “Holds” in line 25 down through “education” in line 26.

AMENDMENT NO. 4

On page 5, in line 1, strike “The” and substitute “**(I) SUBJECT TO SUBPARAGRAPH (II) OF THIS PARAGRAPH, THE**”; after line 3, insert:

**“(II) THE GOVERNING BODY MAY FUND THE RESERVE REQUIRED BY THE INITIAL RESERVE STUDY OVER THREE IMMEDIATELY SUCCESSIVE BUDGET CYCLES FOLLOWING THE FISCAL YEAR IN WHICH THE INITIAL RESERVE STUDY IS CONDUCTED.”;**

and in line 16, strike “**THE**” and substitute “**(1) SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, THE**”.

On page 8, in line 12, strike “**RESERVES**” and substitute “**(1) SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, RESERVES**”.

On page 5 after line 19, and on page 8 after line 15, in each instance, insert:

**“(2) THE GOVERNING BODY MAY FUND THE RESERVES REQUIRED BY THE INITIAL RESERVE STUDY OVER THREE IMMEDIATELY SUCCESSIVE BUDGET CYCLES FOLLOWING THE FISCAL YEAR IN WHICH THE INITIAL RESERVE STUDY IS CONDUCTED.”**

**AMENDMENT NO. 5**

On page 5, in line 12, after “paragraph” insert “**FOR A RESIDENTIAL CONDOMINIUM**”; in line 17, after “section” insert “**FOR A RESIDENTIAL CONDOMINIUM**”; in line 33, strike the bracket; and in the same line, after “a” insert “**RESIDENTIAL**”.

On pages 5 and 6, strike beginning with “in” in line 33 on page 5 down through “County” in line 1 on page 6.

On page 6, in line 2, strike the bracket; in line 17, strike the brackets; and in the same line, strike “**(C)**”.

On page 7, in line 16, strike the brackets; and in the same line, strike “**(D)**”.

On page 8, in line 1, after “a” insert “**RESIDENTIAL**”.
