AMENDMENTS TO HOUSE BILL 669

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in the sponsor line, strike “**Delegate Wilkins**” and substitute “**Delegates Wilkins, Bridges, Charkoudian, Wells, Pendergrass, Pena–Melnyk, Bagnall, Belcastro, Bhandari, Carr, Cullison, Hill, Johnson, Kaiser, Kelly, Kerr, Kipke, Krebs, Landis, R. Lewis, Rosenberg, Sample–Hughes, and K. Young**”.

AMENDMENT NO. 2

On page 2, in line 3, after “**CONTINUOUS**” insert “**AND NONCLINICAL**”; in line 7, after “**GUIDANCE**” insert “**, SUPPLEMENTING THE SERVICES OF HEALTH CARE PROVIDERS,**”; in line 10, strike “**COUNSELING**” and substitute “**COACHING**”; in line 25, strike “**NECESSARY**” and substitute “**INDICATED**”; and in line 26, strike “**IS:**” and substitute “**MEETS THE COVERAGE REQUIREMENTS SET BY THE DEPARTMENT.**”.

On pages 2 and 3, strike in their entirety the lines beginning with line 27 on page 2 through line 4 on page 3, inclusive.

On page 3, in line 7, strike “**(C)**” and substitute “**(D)**”; strike in their entirety lines 10 and 11; in line 12, strike “**(10)**” and substitute “**(9)**”; and after line 16, insert:

“(B) THIS SECTION MAY NOT BE CONSTRUED TO LIMIT THE AUTHORITY OF THE HEALTH SERVICES COST REVIEW COMMISSION TO SET THE APPROPRIATE RATES FOR HOSPITAL SERVICES.”;

and in lines 17, 24, and 30, strike “**(B)**”, “**(C)**”, and “**(D)**”, respectively, and substitute “**(C)**”, “**(D)**”, and “**(E)**”, respectively.

On page 4, in lines 6 and 15, strike “**(E)**” and “**(F)**”, respectively, and substitute “**(F)**” and “**(G)**”, respectively; and in line 7, strike “**NECESSARY**” and substitute “**INDICATED**”.

On page 5, in line 7, strike “**(G)**” and substitute “**(H)**”; in line 8, strike “**NECESSARY**” and substitute “**INDICATED**”; and in lines 8 and 9, strike “**AND HOME VISITING SERVICES**”.
