A BILL ENTITLED

1 AN ACT concerning

2 **Talbot County – Deer and Turkey Hunting – Sundays**

3 FOR the purpose of authorizing the Department of Natural Resources to allow a person to
4 hunt deer on each Sunday of the deer hunting seasons from a certain Sunday in
5 October through a certain Sunday in January, inclusive, in Talbot County;
6 authorizing the Department to allow a person to hunt turkey on each Sunday of the
7 spring turkey hunting season in Talbot County; and generally relating to deer and
8 turkey hunting in Talbot County on a Sunday.

9 BY repealing and reenacting, with amendments,
10 Article – Natural Resources
11 Section 10–410(a)
12 Annotated Code of Maryland
13 (2012 Replacement Volume and 2021 Supplement)

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
15 That the Laws of Maryland read as follows:

16 **Article – Natural Resources**

17 10–410.

18 (a) (1) The Department may allow a person to hunt on each Sunday of the
19 game bird and game mammal seasons in:

20 (i) Allegany County;

21 (ii) Cecil County;

22 (iii) Garrett County;

1 (iv) St. Mary's County; and

2 (v) Washington County.

3 (2) The Department may allow a person to hunt deer on each Sunday of the
4 deer hunting seasons from the first Sunday in October through the second Sunday in
5 January, inclusive, in:

6 (i) Carroll County;

7 (ii) Dorchester County; [and]

8 (iii) Frederick County; **AND**

9 **(IV) TALBOT COUNTY.**

10 (3) (i) Subject to subparagraph (ii) of this paragraph, the Department
11 may allow a person to hunt deer on each Sunday of the deer hunting seasons from 30
12 minutes before sunrise until 10:30 a.m. in:

13 1. Kent County; and

14 2. Montgomery County.

15 (ii) The time restrictions under this paragraph do not apply:

16 1. To a participant in a junior deer hunt authorized under
17 this subtitle;

18 2. On one Sunday designated by the Department during the
19 deer firearms season;

20 3. In Kent County, on each Sunday during the deer bow
21 hunting season and the deer muzzle loader season; and

22 4. In Montgomery County, on one Sunday designated by the
23 Department during the deer bow hunting season.

24 (4) The Department may allow a person to hunt deer during the deer
25 firearms season:

26 (i) On each Sunday in:

27 1. Calvert County;

28 2. Caroline County;

- 3. Charles County;
- 4. Harford County;
- 5. Queen Anne's County;
- 6. Somerset County; and
- 7. Worcester County;

(ii) On the first Sunday in[:

- 1.] Anne Arundel County; and
- [2. Talbot County; and]

(iii) In Wicomico County, on:

- 1. The first Sunday; and
- 2. The second Sunday from 30 minutes before sunrise until

10:30 a.m.

(5) The Department may allow a person to hunt deer during the deer bow hunting season on:

(i) The last three Sundays in October and the first two Sundays in November in:

- 1. Calvert County;
- 2. Caroline County;
- 3. Charles County;
- 4. Harford County;
- 5. Queen Anne's County;
- 6. Somerset County;
- 7. [Talbot County;
- 8.] Wicomico County; and

1 [9.] 8. Worcester County; and

2 (ii) The first Sunday in November in Anne Arundel County.

3 (6) The Department may allow a person to hunt turkey on each Sunday of
4 the spring turkey hunting season in:

5 (i) Calvert County;

6 (ii) Caroline County;

7 (iii) Carroll County;

8 (iv) Charles County;

9 (v) Dorchester County; [and]

10 (vi) Kent County; AND

11 (VII) TALBOT COUNTY.

12 (7) Notwithstanding any other provision of this subtitle, the Department
13 may allow a person with a deer management permit to shoot deer on any Sunday
14 throughout the year in accordance with the terms of the permit.

15 (8) The Department may allow a person using a State certified raptor to
16 hunt game birds or mammals on each Sunday during the open season for the game birds
17 or mammals.

18 (9) The Department may allow an unarmed person participating in an
19 organized fox chase to chase foxes on Sunday.

20 (10) The Department may allow a person shooting pen-reared game birds
21 or tower-released flighted mallard ducks to hunt on Sunday at a regulated shooting ground
22 in accordance with § 10-906 of this title.

23 (11) The Department may allow a person who is 16 years old or younger to
24 hunt on Sunday if participating in a junior hunt established by the Department in
25 accordance with this subtitle.

26 (12) Except as provided in paragraphs (8) through (10) of this subsection and
27 subject to paragraph (7) of this subsection, a person may not hunt on Sunday in:

28 (i) Baltimore City;

29 (ii) Baltimore County;

1 (iii) Howard County; or

2 (iv) Prince George's County.

3 (13) A person may not hunt migratory game birds on Sunday.

4 (14) A person may not hunt on public land within the State park system on
5 Sunday.

6 (15) The Department may not allow a person to hunt on public land
7 designated for hunting by the Department on Sunday except in:

8 (i) Allegany County;

9 (ii) Cecil County;

10 (iii) Garrett County;

11 (iv) St. Mary's County;

12 (v) Washington County;

13 (vi) Dorchester County, for turkey during the spring turkey hunting
14 season; and

15 (vii) Frederick County, for deer from the first Sunday in October
16 through the second Sunday in January of the following year, inclusive.

17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
18 1, 2022.
