CHAPTER
AN ACT concerning
Calvert County - Sunday Hunting
FOR the purpose of authorizing the Department of Natural Resources to allow a person thunt <u>during a certain time period</u> on <u>each Sunday certain Sundays</u> of the game bin and game mammal seasons in Calvert County; and generally relating to Sundahunting in Calvert County.
BY repealing and reenacting, with amendments, Article – Natural Resources Section 10–410(a) Annotated Code of Maryland (2012 Replacement Volume and 2021 Supplement)
