1 AN ACT concerning

2 **Public Health – Cottage Food Businesses – Annual Revenues**

3 FOR the purpose of altering the definition of “cottage food business” for the purpose of
4 increasing the cap on the annual revenue from the sale of cottage food products that
5 a cottage food business may earn; and generally relating to cottage food businesses
6 and annual revenues.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
18 That the Laws of Maryland read as follows:

1 Article – Health – General

2 21–301.

3 (a) In this subtitle the following words have the meanings indicated.

4 (b–1) “Cottage food business” means a business that:

5 (1) Produces or packages cottage food products in a residential kitchen;

6 (2) Sells the cottage food products in accordance with § 21–330.1 of this
7 subtitle and regulations adopted by the Department; and

8 (3) Has annual revenues from the sale of cottage food products in an
9 amount not exceeding [~~\$25,000~~] ~~\$100,000~~ \$50,000.

10 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
11 October 1, 2022.
