SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 1 2 That the Laws of Maryland read as follows: 3 Article - Alcoholic Beverages 2-212. 4 This subsection does not apply to a Class 6 pub-brewery license. 5 (a) (1) 6 The holder of a distillery, rectifying, winery, limited winery, brewery, (2)7 or farm brewery license may apply for and obtain, under a different name, one or more 8 additional distillery, rectifying, winery, limited winery, brewery, or farm brewery licenses for the same or different premises. 9 10 (3)The holder of multiple manufacturer's licenses at the same location may allow the sampling, sales, and consumption of products produced under the 11 12 licenses at each of the licensed premises. 13 The sampling, sales, and consumption of products shall be (ii) consistent with the authorization for each license. 14 15 The additional licenses may be issued to different persons or under 16 trade names used by persons occupying all or a part of the same premises. 17 A holder of a license listed in paragraph (2) of this subsection may hold (5)additional licenses listed in paragraph (2) of this subsection of the same or of a different 18 19 class. 20 (6)The holder of a micro-brewery license may apply for and obtain not 21more than one additional micro-brewery license for another premises. 2225-102.23This title applies only in Montgomery County. 25-401. 2425The following sections of Title 2, Subtitle 2 ("Manufacturer's Licenses") of 26 Division I of this article apply in the county without exception or variation: 27 § 2–201 ("Issuance by Comptroller"); (1) 28 (2)§ 2–202 ("Class 1 distillery license");

1 (b) The license may be issued to the holder of: 2 a Class B beer, wine, and liquor (on-sale) license that is issued for use 3 on the premises of a restaurant located in the county; 4 subject to subsection (c) of this section, a Class D beer and wine license that is issued for the sale of beer and wine, at retail, at the place described in the license, 5 6 for on– and off–premises consumption; 7 a Class H beer and wine license that is issued for the sale of beer and 8 wine at a hotel or restaurant, at retail, at the place described in the license, for on-premises 9 consumption; [or] 10 a Class BD-BWL license that is issued for the sale of beer and wine for 11 on- and off-premises consumption, and liquor for on-premises consumption, at the place described in the license; OR 12 13 **(5)** A CLASS B-BWL (CLUBHOUSE/LODGE) LICENSE THAT IS ISSUED 14 FOR THE SALE OF BEER AND WINE FOR ON- AND OFF-PREMISES CONSUMPTION, AND 15 LIQUOR FOR ON-PREMISES CONSUMPTION, AT THE PLACE DESCRIBED IN THE 16 LICENSE. 17 The [Comptroller] COMMISSION may not issue more than an aggregate 18 amount of two Class 7 micro-brewery licenses to holders of Class D beer and wine licenses in the Town of Kensington. 19 20 A holder of the license shall enter into a written agreement with the Alcohol 21Beverage Services for the sale and resale of malt beverages brewed under the license. 22 (e) Subject to paragraphs (2), (3), and (4) of this subsection, the holder of a (1) 23Class 7 micro-brewery license may: 24brew in two locations using the same Class 7 micro-brewery (i) license; and 2526 obtain a Class 2 rectifying license for the premises at the two (ii) 27locations authorized under item (i) of this paragraph. 28The holder of a Class 7 micro-brewery license may brew in two locations using the same Class 7 micro-brewery license if the license holder: 2930 requests permission by submitting a written application to the (i)

[Comptroller] **COMMISSION**; and

- 1 (3)Before authorizing a holder of a Class 7 micro-brewery license to brew 2 in two locations using the same Class 7 micro-brewery license, the [Comptroller] **COMMISSION** shall: 3 make a determination that a second location to brew additional 4 capacity is necessary due to insufficient space at the existing Class 7 license location; and 5 6 (ii) consider any other factor relevant to approval of the application. 7 (4) Notwithstanding any other provision of this article, a holder of a Class 7 micro-brewery license may not serve or sell malt beverages for on- or off-premises 8 9 consumption at the second brewing location authorized under this subsection. 10 25-407. 11 A HOLDER OF A CLASS B-BWL (CLUBHOUSE/LODGE) LICENSE MAY BE 12 ISSUED A CLASS 4 LIMITED WINERY LICENSE TO SELL AND SERVE THE FERMENTED 13 AND DISTILLED PRODUCTS THAT THE HOLDER MANUFACTURES FOR ON- AND 14 OFF-PREMISES CONSUMPTION. 15 THE RESTRICTIONS UNDER § 2-206(B)(5)(III), (6)(II), AND (9) AND THE (B) NOTICE REQUIREMENT UNDER § 2–206(B)(9) OF THIS ARTICLE DO NOT APPLY TO A 16 17 LICENSE ISSUED UNDER THIS SECTION. 18 25-1003.19 There is a Class B–BWL (clubhouse/lodge) license. (a) 20 The Board may issue a Class B-BWL (clubhouse/lodge) license to the Executive Director of the Montgomery County Revenue Authority or the designee of the 2122 Executive Director, for use by a multiuse facility that accommodates a golf course, a restaurant, a clubhouse, a tasting bar, and the catering of events anywhere on the property. 2324 (c) The license authorizes the license holder to: sell beer and wine for off-premises consumption; 25(1) 26 (2) sell beer, wine, and liquor for on-premises consumption; and 27 (3) offer samples of alcoholic beverages at no charge or for a fee. 28(d) The restrictions contained in § 25–902(b) of this title do not apply to the
