A BILL ENTITLED

1 AN ACT concerning

2 **Montgomery County – Alcoholic Beverages – Class B Beer, Wine, and Liquor**
3 **(Clubhouse/Lodge) License – Manufacturer’s Licenses**

4 **MC 23–22**

5 FOR the purpose of authorizing the holder of a Class B–BWL (clubhouse/lodge) license in
6 Montgomery County to be issued a Class 4 limited winery license and a Class 7
7 micro–brewery license to manufacture, sell, and serve certain products; providing
8 that certain restrictions and requirements on the holder of a Class 4 limited winery
9 license do not apply to the holder of both licenses; and generally relating to alcoholic
10 beverages licenses in Montgomery County.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
2 That the Laws of Maryland read as follows:

3 **Article – Alcoholic Beverages**

4 2–212.

5 (a) (1) This subsection does not apply to a Class 6 pub–brewery license.

6 (2) The holder of a distillery, rectifying, winery, limited winery, brewery,
7 or farm brewery license may apply for and obtain, under a different name, one or more
8 additional distillery, rectifying, winery, limited winery, brewery, or farm brewery licenses
9 for the same or different premises.

10 (3) (i) The holder of multiple manufacturer’s licenses at the same
11 location may allow the sampling, sales, and consumption of products produced under the
12 licenses at each of the licensed premises.

13 (ii) The sampling, sales, and consumption of products shall be
14 consistent with the authorization for each license.

15 (4) The additional licenses may be issued to different persons or under
16 trade names used by persons occupying all or a part of the same premises.

17 (5) A holder of a license listed in paragraph (2) of this subsection may hold
18 additional licenses listed in paragraph (2) of this subsection of the same or of a different
19 class.

20 (6) The holder of a micro–brewery license may apply for and obtain not
21 more than one additional micro–brewery license for another premises.

22 25–102.

23 This title applies only in Montgomery County.

24 25–401.

25 (a) The following sections of Title 2, Subtitle 2 (“Manufacturer’s Licenses”) of
26 Division I of this article apply in the county without exception or variation:

27 (1) § 2–201 (“Issuance by Comptroller”);

28 (2) § 2–202 (“Class 1 distillery license”);

29 (3) § 2–204 (“Class 2 rectifying license”);

30 (4) [§ 2–206 (“Class 4 limited winery license”);

1 (5) § 2–207 (“Class 5 brewery license”);

2 [(6)] (5) § 2–210 (“Class 8 farm brewery license”);

3 [(7)] (6) § 2–211 (“Residency requirement”);

4 [(8)] (7) § 2–212 (“Additional licenses”);

5 [(9)] (8) § 2–213 (“Additional fees”);

6 [(10)] (9) § 2–214 (“Sale or delivery restricted”);

7 [(11)] (10) § 2–216 (“Interaction between manufacturing entities and
8 retailers”);

9 [(12)] (11) § 2–217 (“Distribution of alcoholic beverages — Prohibited
10 practices”); and

11 [(13)] (12) § 2–218 (“Restrictive agreements between producers and
12 retailers — Prohibited”).

13 (b) Section 2–215 (“Beer sale on credit to retail dealer prohibited”) of Division I of
14 this article does not apply in the county.

15 (c) The following sections of Title 2, Subtitle 2 (“Manufacturer’s Licenses”) of
16 Division I of this article apply in the county:

17 (1) § 2–203 (“Class 9 limited distillery license”), subject to § 25–406 of this
18 subtitle;

19 (2) § 2–205 (“Class 3 winery license”), subject to § 25–403 of this subtitle;

20 (3) **§ 2–206 (“CLASS 4 LIMITED WINERY LICENSE”), SUBJECT TO §**
21 **25–407 OF THIS SUBTITLE;**

22 (4) § 2–208 (“Class 6 pub–brewery license”), subject to § 25–404 of this
23 subtitle; and

24 [(4)] (5) § 2–209 (“Class 7 micro–brewery license”), subject to § 25–405 of
25 this subtitle.

26 25–405.

27 (a) This section applies to a Class 7 micro–brewery (on– and off–sale) license in
28 the county.

1 (b) The license may be issued to the holder of:

2 (1) a Class B beer, wine, and liquor (on-sale) license that is issued for use
3 on the premises of a restaurant located in the county;

4 (2) subject to subsection (c) of this section, a Class D beer and wine license
5 that is issued for the sale of beer and wine, at retail, at the place described in the license,
6 for on- and off-premises consumption;

7 (3) a Class H beer and wine license that is issued for the sale of beer and
8 wine at a hotel or restaurant, at retail, at the place described in the license, for on-premises
9 consumption; [or]

10 (4) a Class BD-BWL license that is issued for the sale of beer and wine for
11 on- and off-premises consumption, and liquor for on-premises consumption, at the place
12 described in the license; **OR**

13 **(5) A CLASS B-BWL (CLUBHOUSE/LODGE) LICENSE THAT IS ISSUED**
14 **FOR THE SALE OF BEER AND WINE FOR ON- AND OFF-PREMISES CONSUMPTION, AND**
15 **LIQUOR FOR ON-PREMISES CONSUMPTION, AT THE PLACE DESCRIBED IN THE**
16 **LICENSE.**

17 (c) The [Comptroller] **COMMISSION** may not issue more than an aggregate
18 amount of two Class 7 micro-brewery licenses to holders of Class D beer and wine licenses
19 in the Town of Kensington.

20 (d) A holder of the license shall enter into a written agreement with the Alcohol
21 Beverage Services for the sale and resale of malt beverages brewed under the license.

22 (e) (1) Subject to paragraphs (2), (3), and (4) of this subsection, the holder of a
23 Class 7 micro-brewery license may:

24 (i) brew in two locations using the same Class 7 micro-brewery
25 license; and

26 (ii) obtain a Class 2 rectifying license for the premises at the two
27 locations authorized under item (i) of this paragraph.

28 (2) The holder of a Class 7 micro-brewery license may brew in two locations
29 using the same Class 7 micro-brewery license if the license holder:

30 (i) requests permission by submitting a written application to the
31 [Comptroller] **COMMISSION**; and

32 (ii) obtains written approval from the [Comptroller] **COMMISSION**.

1 (3) Before authorizing a holder of a Class 7 micro-brewery license to brew
2 in two locations using the same Class 7 micro-brewery license, the [Comptroller]
3 COMMISSION shall:

4 (i) make a determination that a second location to brew additional
5 capacity is necessary due to insufficient space at the existing Class 7 license location; and

6 (ii) consider any other factor relevant to approval of the application.

7 (4) Notwithstanding any other provision of this article, a holder of a Class
8 7 micro-brewery license may not serve or sell malt beverages for on- or off-premises
9 consumption at the second brewing location authorized under this subsection.

10 **25-407.**

11 (A) A HOLDER OF A CLASS B-BWL (CLUBHOUSE/LODGE) LICENSE MAY BE
12 ISSUED A CLASS 4 LIMITED WINERY LICENSE TO SELL AND SERVE THE FERMENTED
13 AND DISTILLED PRODUCTS THAT THE HOLDER MANUFACTURES FOR ON- AND
14 OFF-PREMISES CONSUMPTION.

15 (B) THE RESTRICTIONS UNDER § 2-206(B)(5)(III), (6)(II), AND (9) AND THE
16 NOTICE REQUIREMENT UNDER § 2-206(B)(9) OF THIS ARTICLE DO NOT APPLY TO A
17 LICENSE ISSUED UNDER THIS SECTION.

18 **25-1003.**

19 (a) There is a Class B-BWL (clubhouse/lodge) license.

20 (b) The Board may issue a Class B-BWL (clubhouse/lodge) license to the
21 Executive Director of the Montgomery County Revenue Authority or the designee of the
22 Executive Director, for use by a multiuse facility that accommodates a golf course, a
23 restaurant, a clubhouse, a tasting bar, and the catering of events anywhere on the property.

24 (c) The license authorizes the license holder to:

25 (1) sell beer and wine for off-premises consumption;

26 (2) sell beer, wine, and liquor for on-premises consumption; and

27 (3) offer samples of alcoholic beverages at no charge or for a fee.

28 (d) The restrictions contained in § 25-902(b) of this title do not apply to the
29 issuance of a Class B-BWL (clubhouse/lodge) license.

30 (e) **THE LICENSE HOLDER MAY ALSO HOLD:**

1 **(1) A CLASS 4 LIMITED WINERY LICENSE IN ACCORDANCE WITH §**
2 **25-407 OF THIS TITLE; AND**

3 **(2) A CLASS 7 MICRO-BREWERY LICENSE IN ACCORDANCE WITH §**
4 **25-405 OF THIS TITLE.**

5 **(F)** The annual license fee is \$1,000.

6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
7 1, 2022.
