### CHAPTER \_\_\_\_\_

1 AN ACT concerning

### 2 Election Law – Contested Elections

3 FOR the purpose of altering certain definitions to allow a campaign finance entity to pay  
4 expenses associated with contesting an election; *prohibiting a recount under certain*  
5 *circumstances; prohibiting a recount under certain circumstances;* altering the  
6 circumstances under which a petitioner for a recount is not liable for the costs of the  
7 recount; providing that a person who accepts certain public campaign financing may  
8 accept a donation or make a disbursement related to a contested election only if the  
9 person establishes a contested election committee and makes certain disclosures;  
10 providing that a certain system of public campaign financing established by the  
11 governing body of a county may include public financing of a contested election  
12 committee; and generally relating to contested elections.

20 (a) In this article the following words have the meanings indicated unless a  
 21 different meaning is clearly intended from the context.

22 (o) (1) “Contribution” means the gift or transfer, or promise of gift or transfer,  
 23 of money or other thing of value to a campaign finance entity to:

24 (I) promote or assist in the promotion of the success or defeat of a  
 25 candidate, political party, question, or prospective question; AND

26 (II) ASSIST IN THE PAYMENT OF EXPENSES ASSOCIATED WITH  
 27 CONTESTING AN ELECTION UNDER TITLE 12 OF THIS ARTICLE.

28 (2) “Contribution” includes:

29 (i) proceeds from the sale of tickets to a campaign fund–raising  
 30 event; and

31 (ii) a coordinated expenditure as defined in § 13–249 of this article.

32 (3) “Contribution” does not include the costs associated with the  
 33 establishment, administration, or solicitation of voluntary contributions to a political action

1 committee established by a corporation, limited liability company, general partnership,  
 2 limited partnership, membership organization, trade association, cooperative, or  
 3 corporation without capital stock as long as the political action committee only solicits  
 4 contributions from employees of the organization that established the political action  
 5 committee, or members of the organization that established the political action committee,  
 6 and the employees or members are participating in a payroll deduction program established  
 7 by the employer of the employee or member.

 9 thing of value by or on behalf of a campaign finance entity to:

10 (1) promote or assist in the promotion of the success or defeat of a

16           (a) In this section, “petitioner” includes a counterpetitioner.

17           (b) (1) Except as provided in paragraph (2) of this subsection, each petitioner  
 18 shall pay the cost of a recount requested under this subtitle and the petitioner’s bond is  
 19 liable for the cost.

20           (2) The petitioner is not liable for the costs of the recount if:

21                   (i) the outcome of the election is changed;

22                   (ii) the petitioner has gained a number of votes, for the petitioner’s  
 23 candidacy or for or against the question that is the subject of the petition, equal to 2% or  
 24 more of the total votes cast for the office or on the question, in all precincts being recounted;  
 25 or

26                   (iii) 1. the margin of difference in the number of votes received by  
 27 an apparent winner and the losing candidate with the highest number of votes for an office  
 28 is [0.1%] **0.25%** or less of the total votes cast for those candidates; or

29                                   2. in the case of a question, the margin of difference between  
 30 the number of votes cast for and the number cast against the question is [0.1%] **0.25%** or  
 31 less.

32           (c) If the petitioner is not liable for the costs of the recount as provided in  
 33 subsection (b) of this section, a county shall pay the costs of the recount in that county.

6                   **(I) A RECOUNT UNDER SUBTITLE 1 OF THIS TITLE; OR**

7                   **(II) A JUDICIAL CHALLENGE UNDER SUBTITLE 2 OF THIS TITLE.**

8           **(2) “CONTESTED ELECTION” INCLUDES AN ELECTION THAT MAY BE**  
9 **SUBJECT TO A RECOUNT UNDER SUBTITLE 1 OF THIS TITLE, BUT FOR WHICH A**  
10 **RECOUNT DOES NOT OCCUR BECAUSE NEITHER CANDIDATE FILES A FORMAL**  
11 **RECOUNT PETITION OR INITIATES A JUDICIAL ACTION.**

12           **(C) “CONTESTED ELECTION COMMITTEE” MEANS AN ENTITY FORMED FOR**  
13 **THE EXCLUSIVE PURPOSE OF RECEIVING DONATIONS AND MAKING DISBURSEMENTS**  
14 **RELATING TO A CONTESTED ELECTION.**

14           **(2) BE IN ACCORDANCE WITH THE PURPOSE OF THE ENTITY.**

28 **BUSINESS OF MAKING LOANS; OR**

1                   **(II) THE PERSONAL FUNDS OF A CANDIDATE OR THE**  
2 **CANDIDATE'S SPOUSE IF THE CONTESTED ELECTION COMMITTEE WAS ESTABLISHED**  
3 **TO FINANCE A RECOUNT OF AN ELECTION IN WHICH THE CANDIDATE WAS ON THE**  
4 **BALLOT.**

17 **PERIOD OF 2 YEARS AFTER FILING A FINAL REPORT.**

4 **OUTSTANDING OBLIGATIONS OF THE CONTESTED ELECTION COMMITTEE DURING**  
5 **THE REPORTING PERIOD.**

6           **(B) (1) IF THE PERSON WHO ESTABLISHED THE CONTESTED ELECTION**  
7 **COMMITTEE HAS FILED A PETITION FOR A RECOUNT UNDER SUBTITLE 1 OF THIS**  
8 **TITLE OR HAS FILED A COMPLAINT IN THE CIRCUIT COURT UNDER SUBTITLE 2 OF**  
9 **THIS TITLE, THE TREASURER OF THE CONTESTED ELECTION COMMITTEE SHALL**  
10 **FILE THE CONTESTED ELECTION COMMITTEE'S FIRST REPORT ON OR BEFORE THE**  
11 **FIRST DAY AFTER THE EARLIER OF:**

12                           **(I) THE DAY THE PERSON WHO ESTABLISHED THE CONTESTED**  
13 **ELECTION COMMITTEE FILED THE PETITION FOR A RECOUNT; OR**

14                           **(II) THE DAY THE PERSON WHO ESTABLISHED THE CONTESTED**  
15 **ELECTION COMMITTEE FILED THE COMPLAINT IN THE CIRCUIT COURT.**

16           **(2) IF THE PERSON WHO ESTABLISHED THE CONTESTED ELECTION**  
17 **COMMITTEE HAS NOT FILED A PETITION FOR A RECOUNT UNDER SUBTITLE 1 OF**  
18 **THIS TITLE OR FILED A COMPLAINT IN THE CIRCUIT COURT UNDER SUBTITLE 2 OF**  
19 **THIS TITLE, THE TREASURER OF THE CONTESTED ELECTION COMMITTEE SHALL**  
20 **FILE THE CONTESTED ELECTION COMMITTEE'S FIRST REPORT ON OR BEFORE THE**  
21 **DAY THAT IS 7 DAYS AFTER THE DAY THAT THE CONTESTED ELECTION COMMITTEE**  
22 **OF THE OPPOSING CANDIDATE OR OPPOSING PARTY FILED ITS FIRST REPORT**  
23 **UNDER PARAGRAPH (1) OF THIS SUBSECTION.**

24           **(C) THE TREASURER OF A CONTESTED ELECTION COMMITTEE SHALL FILE**  
25 **SUBSEQUENT REPORTS ON OR BEFORE:**

26                           **(1) THE MONDAY THAT IS 30 DAYS AFTER THE DUE DATE OF THE**  
27 **FIRST REPORT FILED BY THE CONTESTED ELECTION COMMITTEE UNDER**  
28 **SUBSECTION (B) OF THIS SECTION;**

29                           **(2) THE MONDAY THAT IS 60 DAYS AFTER THE DUE DATE OF THE**  
30 **FIRST REPORT FILED BY THE CONTESTED ELECTION COMMITTEE UNDER**  
31 **SUBSECTION (B) OF THIS SECTION; AND**

32                           **(3) THE THIRD WEDNESDAY IN JANUARY OF EACH YEAR THAT THE**  
33 **CONTESTED ELECTION COMMITTEE REMAINS IN EXISTENCE.**



1           (D) THE STATE BOARD SHALL, BY REGULATION, ESTABLISH THE  
2 REPORTING PERIODS FOR EACH OF THE REPORTS REQUIRED UNDER THIS  
3 SUBTITLE.

4           (E) IF THE TREASURER OF A CONTESTED ELECTION COMMITTEE FAILS TO  
5 PROVIDE ALL THE INFORMATION REQUIRED ON A REPORT UNDER THIS SUBTITLE:

6               (1) THE STATE BOARD SHALL NOTIFY THE TREASURER IN WRITING  
7 OF THE PARTICULAR DEFICIENCIES; AND

8               (2) THE TREASURER SHALL FILE AN AMENDED REPORT THAT  
9 INCLUDES ALL THE INFORMATION REQUIRED WITHIN 30 DAYS AFTER SERVICE OF  
10 THE NOTICE.

11 12-309.

12           (A) (1) THE STATE BOARD SHALL ASSESS LATE FILING FEES FOR  
13 FAILURE TO PROPERLY FILE A REPORT UNDER THIS SUBTITLE.

14               (2) THE STATE BOARD SHALL ASSESS THE FEES IN THE FOLLOWING  
15 AMOUNTS FOR EACH DAY OR PART OF A DAY THAT A REPORT UNDER THIS SUBTITLE  
16 IS OVERDUE:

17                       (I) \$20 FOR EACH OF THE FIRST 7 DAYS;

18                       (II) \$35 FOR EACH OF THE FOLLOWING 7 DAYS; AND

19                       (III) \$50 FOR EACH DAY THEREAFTER.

20               (3) THE MAXIMUM FEE PAYABLE FOR A REPORT IS \$1,000.

23 ELECTION COMMITTEE.

24                       (II) IF THE CONTESTED ELECTION COMMITTEE HAS  
25 INSUFFICIENT FUNDS WITH WHICH TO PAY THE FULL AMOUNT OF THE LATE FILING  
26 FEE IN A TIMELY MANNER, AFTER THE ACCOUNT OF THE CONTESTED ELECTION  
27 COMMITTEE IS EXHAUSTED THE BALANCE OF THE LATE FILING FEE IS THE  
28 LIABILITY OF THE TREASURER.

29               (2) LATE FILING FEES SHALL BE DISTRIBUTED TO THE FAIR  
30 CAMPAIGN FINANCING FUND ESTABLISHED UNDER § 15-103 OF THIS ARTICLE.

1           **(3) (I) THE STATE BOARD SHALL ACCEPT AN OVERDUE REPORT**  
2 **THAT IS SUBMITTED WITHOUT PAYMENT OF THE LATE FILING FEE, BUT THE REPORT**  
3 **IS NOT CONSIDERED FILED UNTIL THE FEE HAS BEEN PAID.**

4           **(II) AFTER AN OVERDUE REPORT IS RECEIVED UNDER**  
5 **SUBPARAGRAPH (I) OF THIS PARAGRAPH, NO FURTHER LATE FILING FEE SHALL BE**  
6 **INCURRED.**

7           **(4) THE TREASURER OF A CONTESTED ELECTION COMMITTEE THAT**  
8 **FAILS TO PROPERLY FILE A REPORT MAY SEEK RELIEF FROM A LATE FILING FEE**  
9 **IMPOSED UNDER THIS SECTION FOR JUST CAUSE AS PROVIDED IN § 13-337 OF THIS**  
10 **ARTICLE.**

12           **(A) (1) IF THE STATE BOARD DETERMINES THAT THERE HAS BEEN FOR**  
13 **MORE THAN 30 DAYS A FAILURE TO FILE A REPORT OR PAY A LATE FILING FEE**  
14 **UNDER THIS SUBTITLE, THE STATE BOARD SHALL ISSUE THE NOTICE REQUIRED**  
15 **UNDER PARAGRAPH (2) OF THIS SUBSECTION TO THE TREASURER OF THE**  
16 **CONTESTED ELECTION COMMITTEE IN VIOLATION.**

17           **(2) THE NOTICE SHALL DEMAND THAT, WITHIN 30 DAYS AFTER**  
18 **SERVICE OF THE NOTICE, EITHER:**

19           **(I) THE FAILURE TO FILE BE RECTIFIED AND ANY LATE FILING**  
20 **FEE DUE BE PAID; OR**

21           **(II) THE TREASURER SHOW CAUSE WHY THE STATE BOARD**  
22 **SHOULD NOT ASK THE APPROPRIATE PROSECUTING AUTHORITY TO PROSECUTE**  
23 **THE TREASURER FOR A VIOLATION OF THIS SUBTITLE.**

24           **(3) IN ITS DISCRETION, THE APPROPRIATE PROSECUTING**  
25 **AUTHORITY MAY REFER THE MATTER FOR ACTION TO THE CENTRAL COLLECTION**  
26 **UNIT WITHIN THE DEPARTMENT OF BUDGET AND MANAGEMENT.**

27           **(B) A TREASURER WHO FAILS, WITHOUT CAUSE, TO FILE THE REPORT AND**  
28 **PAY THE LATE FILING FEE WITHIN 30 DAYS AFTER SERVICE OF THE NOTICE**  
29 **REQUIRED UNDER SUBSECTION (A)(2) OF THIS SECTION IS GUILTY OF A**  
30 **MISDEMEANOR AND ON CONVICTION IS SUBJECT TO THE PENALTIES PRESCRIBED IN**  
31 **§ 13-603 OF THIS ARTICLE.**

1           **(A) A CANDIDATE WHOSE CONTESTED ELECTION COMMITTEE HAS FAILED**  
2 **TO FILE A REPORT OR PAY A LATE FILING FEE THAT IS DUE UNDER THIS SUBTITLE**  
3 **ON OR BEFORE THE DEADLINE FOR DECLINING THE NOMINATION SPECIFIED UNDER**
