inconsistent with a federal law, grant agreement, or other federal requirement or with the
terms of a gift or settlement agreement, net interest on all State money allocated by the

receive interest earnings, as accounted for by the Comptroller, shall accrue to the General
Fund of the State.

3 SECTION 2. AND BE IT FURTHER ENACTED, That before July 16, 2022, the 4 Maryland Department of Health shall designate 9–8–8 as the primary phone number for 5 the State's behavioral health crisis hotline to provide crisis intervention services and crisis 6 care coordination to individuals accessing suicide prevention and behavioral health services 7 from any jurisdiction within the State 24 hours a day, 7 days a week under the federal 8 National Suicide Hotline Designation Act of 2020.

9 SECTION 3. AND BE IT FURTHER ENACTED, That, for fiscal year 2024, the 10 Governor shall include in the annual budget bill an appropriation of \$10,000,000 11 <u>\$5,500,000</u> to the 9–8–8 Trust Fund established under § 7.5–5A–02 of the Health – General 12 Article, as enacted by Section 1 of this Act.

SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take effect July
 1, 2022.
