9 SECTION 2. AND BE IT FURTHER ENACTED, That the terms of the initial 10 members of the Commission on History, Culture, and Civics in Education shall expire as 11 follows:

12 (1) the eight members representing the indigenous American tribes, 13 Maryland Latinx community, African American community, and Asian American and 14 Pacific Islander community in 2024; and

15 (2) the six members representing the LGBTQI+ community, differently 16 abled community, teachers, and higher education in 2026.

17 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July 18 1, 2022.
