CHAPTER _____

1 AN ACT concerning

2 **Baltimore County – Orphans’ Court Judges and Surviving Spouses – Pensions**

3 FOR the purpose of requiring Baltimore County to pay Orphans’ Court judges and their
4 surviving spouses a certain pension under certain circumstances; and generally
5 relating to the pension of a judge of the Orphans’ Court for Baltimore County.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
17 That the Laws of Maryland read as follows:

18 **Article – Estates and Trusts**

19 2–108.

1 (x) (1) Except in Montgomery, Frederick, Carroll, Talbot, Cecil, Kent, Queen
2 Anne's, [Baltimore,] Garrett, and Harford counties and Baltimore City, and except as
3 OTHERWISE provided in [paragraphs (3) and (4) of] this subsection, a county shall pay a
4 pension, in the same manner as salaries are paid during active service, to each judge of the
5 Orphans' Court who:

- 6 (i) Has terminated active service;
- 7 (ii) Has reached 60 years of age; and
- 8 (iii) Has completed at least two terms of office.

9 (7) (I) THIS PARAGRAPH APPLIES ONLY IN BALTIMORE COUNTY.

10 (II) AN ORPHAN'S COURT JUDGE IS ELIGIBLE FOR A PENSION
11 UNDER THIS SUBSECTION ONLY IF THE JUDGE WAS IN OFFICE ON OR AFTER
12 JANUARY 1, 2022.

13 (III) THE PENSION SHALL BE THE GREATER OF:

14 1. \$1,200 ANNUALLY; OR

15 2. AN ANNUAL AMOUNT CALCULATED AT THE RATE OF
16 4% OF THE LAST ANNUAL AMOUNT OF COMPENSATION MULTIPLIED BY THE NUMBER
17 OF YEARS OF SERVICE, NOT EXCEEDING 24 YEARS.

18 (IV) 1. SUBJECT TO SUBSUBPARAGRAPH 2 OF THIS
19 SUBPARAGRAPH AND EXCEPT AS PROVIDED IN SUBSUBPARAGRAPH 3 OF THIS
20 SUBPARAGRAPH, A SURVIVING SPOUSE OF AN ORPHANS' COURT JUDGE SHALL BE
21 PAID ONE-HALF OF THE PENSION TO WHICH THE JUDGE WAS ENTITLED AT THE TIME
22 OF THE JUDGE'S DEATH, OR WOULD HAVE BEEN ENTITLED ON ATTAINING 60 YEARS
23 OF AGE.

24 2. A PENSION SHALL BE PAID TO A SURVIVING SPOUSE
25 UNTIL THE SURVIVING SPOUSE'S DEATH OR REMARRIAGE.

26 3. A SURVIVING SPOUSE IS NOT ENTITLED TO A PENSION
27 IF THE SURVIVING SPOUSE WAS MARRIED TO AN ACTIVE OR RETIRED JUDGE FOR A
28 PERIOD OF LESS THAN 3 YEARS BEFORE THE ACTIVE JUDGE'S DEATH OR THE
29 RETIRED JUDGE'S RETIREMENT.

30 [(7)] (8) The pension or salary may be suspended during any month the
31 judge is a full-time employee of any county or of this State.

1 **[(8) (9)]** Notwithstanding any provision of this section an Orphans' Court
2 judge may not receive a pension under this section if the judge is receiving any other State
3 pension based on service as an Orphans' Court judge.

4 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
5 October 1, 2022.
