# Commission to Study the Division of Rehabilitative Rehabilitation Services (Student Job Training Reformation Act)

FOR the purpose of establishing the Commission to Study the Division of Rehabilitative
<u>Rehabilitation</u> Services to evaluate and make recommendations on improving
various aspects of the Division of Rehabilitative Rehabilitation
and services; and generally relating to the Commission to Study the Division of
<u>Rehabilitative Rehabilitation</u> Services.

## 9 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 10 That:

11 (a) There is a Commission to Study the State Department of Education's Division 12 of <del>Rehabilitative</del> <u>Rehabilitation</u> Services.

1 The Division of Rehabilitative Rehabilitation Services shall provide staff for (d)  $\mathbf{2}$ the Commission. 3 (e) A member of the Commission: 4 may not receive compensation as a member of the Commission; but (1) $\mathbf{5}$ (2)is entitled to reimbursement for expenses under the Standard State 6 Travel Regulations, as provided in the State budget. 7 (f) The Commission shall evaluate and make recommendations on: 8 methods for improving stakeholder input on the Division of (1)Rehabilitative Rehabilitation Services' programs and services; 9 (2)10 methods for improving the relationship and communication between 11 transition professionals working at the Division of Rehabilitative Rehabilitation Services 12and the Developmental Disabilities Administration; 13(3)methods for improving the amount of time it takes to provide vocational rehabilitation and transitional services; 1415(4) methods for improving public-private partnerships to assist more 16 Division of Rehabilitative Rehabilitation Services' clients: 17methods for improving accountability and transparency of the Division (5)18 of Rehabilitative Rehabilitation Services' programs and services: whether the eligibility criteria for the Division of Rehabilitative 19 (6)20Rehabilitation Services' programs and services should be altered; 21whether the Division of <del>Rehabilitative</del> Rehabilitation Services should (7)22continue to be a division of the State Department of Education or should be transferred to 23another State agency; 24if the Commission determines that the Division of Rehabilitative (8)25Rehabilitation Services should continue to be a division of the State Department of 26Education, whether the Division of Rehabilitative Rehabilitation Services should have a 27governing board separate from the State Board of Education; 28(9)whether there are specific budgetary requests that could support the 29job training programs provided by the Division of Rehabilitative <u>Rehabilitation</u> Services; 30 and any other improvements to the Division of Rehabilitative 31(10)32Rehabilitation Services' programs and services the Commission considers appropriate.

1 (g) The Commission shall meet at least five times between June 1, 2022, and 2 December 15, 2022.

3 (h) On or before December 15, 2022, the Commission shall report its findings and 4 recommendations to the Governor and, in accordance with § 2–1257 of the State 5 Government Article, the General Assembly.

6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June 7 1, 2022. It shall remain effective for a period of 1 year and 1 month and, at the end of June 8 30, 2023, this Act, with no further action required by the General Assembly, shall be 9 abrogated and of no further force and effect.
