2 Higher Education – Student Financial Assistance – Alterations and Appropriation

4 FOR the purpose of requiring the Maryland Higher Education Commission to use a certain 5 annual family income determination when awarding a Guaranteed Access Grant; 6 authorizing the Next Generation Scholars of Maryland Program to continue 7 providing certain services to students when they attend an institution of higher 8 education; altering the maximum award amount for an Educational Assistance 9 Grant; providing that a recipient of a Guaranteed Access Grant who becomes ineligible because of a change in family income shall remain eligible for the full 10 11 award term applicable to the recipient with a reduced award amount calculated by 12 the Commission; requiring the Governor to include in the annual budget bill a 13 certain appropriation for Delegate Howard P. Rawlings Educational Excellence Awards; altering the qualifications for the 2+2 Transfer Scholarship Program; and 14 15 generally relating to student financial assistance programs.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:
Article - Education
18–303.
(a) Subject to subsection (e) of this section, each recipient of a Delegate Howard P. Rawlings Educational Excellence Award shall:
(3) Demonstrate a definite financial need to:
(i) For an Educational Assistance Grant, the Office; or
(ii) For a Guaranteed Access Grant, the Office or an institution of higher education that complies with § 18–303.3 of this subtitle; and
(b) Except as provided in subsection (c) of this section, each recipient of a Guaranteed Access Grant shall:
(6) Subject to subsection (d) of this section, have an annual family income below a poverty index determined by the Commission; and
(c) (1) Subject to paragraph (2) of this subsection, an individual who has successfully obtained a high school diploma by examination under § 11–808 of the Labor and Employment Article is exempt from the requirements of subsection (b) of this section.
(2) An individual described under paragraph (1) of this subsection is eligible for a Guaranteed Access Grant if the individual:
(v) Subject to subsection (d) of this section, has an annual family income below a poverty index determined by the Commission.
(d) (1) To determine the annual family income eligibility of an applicant for a Guaranteed Access Grant, the Office or an institution of higher education that complies with § 18–303.3 of this subtitle may not consider an amount received by the applicant as an earned income credit under § 32 of the Internal Revenue Code.
(2) When awarding a Guaranteed Access Grant, the Commission shall use the annual family income determination used when the student prequalified under subsection (e)(1) of this section.


Except as provided in paragraph (2) of this subsection, a student in

grade 7 or grade 8 who applies and qualifies for a Guaranteed Access Grant on the basis of

- 1 financial need as established by the Commission shall prequalify for a Guaranteed Access 2Grant to be used at the time of enrollment in an institution of higher education by agreeing 3 in writing, as a secondary and undergraduate student, to: 4 (i) Satisfy the attendance policy of the applicable school; 5 (ii) Refrain from substance abuse: 6 Provide information required by the Commission or the State (iii) 7 Board of Education: Apply for admission to an institution of higher education during 8 (iv) 9 the student's senior year of high school; 10 (v) Complete and file on a timely basis applications for federal 11 student aid for each year that the student plans to enroll in postsecondary education; 12 (vi) Participate in the Next Generation Scholars of Maryland 13 Program established in § 18–303.1 of this subtitle until the student graduates from high school and matriculates at an institution of higher education; 14 15 Maintain a cumulative grade point average of at least 2.5 on a 16 4.0 scale or its equivalent; and (viii) Satisfy any other program requirements set by the Office, the 17 18 Commission, the State Board of Education, or the State Department of Education. 19 A student in grade 9 or grade 10 shall prequalify for a Guaranteed 20 Access Grant to be used at the time of enrollment in an institution of higher education if 21the student: 22 (i) Otherwise meets the conditions of paragraph (1) of this 23subsection; and 24 Is eligible for free or reduced priced meals; or (ii) 1. 25 Attends a school that participates in the U.S. Department of Agriculture Community Eligibility Provision and the student is identified by: 26 27 Direct certification; or Α. 28 B.
