- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 That the Laws of Maryland read as follows:

1 (B) THE PURPOSE OF THE PILOT PROGRAM IS TO REDUCE RECIDIVISM BY 2 OFFERING DEFENDANTS AN OPPORTUNITY TO PARTICIPATE IN FULL-TIME JOB 3 TRAINING AND JOB PLACEMENT PROGRAMS AS A CONDITION OF PROBATION, AN 4 ALTERNATIVE TO INCARCERATION, OR A CONDITION OF PRETRIAL RELEASE.

5 (C) TO ACCOMPLISH THE PURPOSE OF THE PILOT PROGRAM, THE 6 ADMINISTRATIVE OFFICE OF THE COURTS SHALL DEVELOP A PLAN TO IMPLEMENT 7 AND MONITOR THE PILOT PROGRAM.

8 (D) (1) ON OR BEFORE JUNE 30, 2025, THE ADMINISTRATIVE OFFICE OF 9 THE COURTS, IN CONSULTATION WITH THE BALTIMORE WORKFORCE 10 DEVELOPMENT BOARD, SHALL SUBMIT AN INTERIM REPORT TO THE GOVERNOR 11 AND, IN ACCORDANCE WITH § 2–1257 OF THE STATE GOVERNMENT ARTICLE, THE 12 GENERAL ASSEMBLY ON THE OPERATION AND RESULTS OF THE PILOT PROGRAM.

13(2) ON OR BEFORE JUNE 30, 2027, THE ADMINISTRATIVE OFFICE OF THE IN CONSULTATION THE BALTIMORE WORKFORCE 14COURTS, WITH DEVELOPMENT BOARD, SHALL SUBMIT A FINAL REPORT TO THE GOVERNOR AND, 15IN ACCORDANCE WITH § 2-1257 OF THE STATE GOVERNMENT ARTICLE, THE 16GENERAL ASSEMBLY ON THE OPERATION AND RESULTS OF THE PILOT PROGRAM. 17

18 SECTION 2. AND BE IT FURTHER ENACTED, That for in each of fiscal year years 19 2024, 2025, 2026, 2027, and 2028, the Governor shall include in the annual State budget 20 an appropriation of at least \$500,000 to the Baltimore Workforce Development Board, to 21 be distributed to local workforce investment boards or other nonprofit entities that 22 participate in the pilot program by identifying employers and training programs.

23SECTION 3. AND BE IT FURTHER ENACTED, That Section 1 of this Act shall take24effect July 1, 2023.

25 SECTION 3. <u>4.</u> AND BE IT FURTHER ENACTED, That, except as provided in 26 Section <u>3 of this Act</u>, this Act shall take effect July 1, 2022. It shall remain effective for a 27 period of <u>5 6</u> years and, at the end of June <u>30</u>, <u>2027</u> <u>2028</u>, this Act, with no further action 28 required by the General Assembly, shall be abrogated and of no further force and effect.
