# **Child Care Providers and Employees – Bonuses**

#### 3 FOR the purpose of establishing funding for, the award of, and the distribution of bonuses 4 for child care providers and employees; and generally relating to bonuses for child care providers and employees. 5

#### 6 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 7 That:

8 For fiscal year <del>2024</del> 2023, the Governor shall include in the annual (a) (1)9 budget bill an appropriation of \$16,000,000 to the State Department of Education to carry out this section. 10

6 (f) (1) The Department shall award funds under this section on a first–come, 7 first–served basis.

8 (2) The Department may continue to award bonuses under this section on 9 or after July 1, <del>2024</del> <u>2023</u>, with funding allocated under subsection (a)(2) of this section.

10 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 11 1, 2022. It shall remain effective for a period of <del>2 years</del> <u>1 year</u> and 6 months and, at the end 12 of December 31, <del>2024</del> <u>2023</u>, this Act, with no further action required by the General 13 Assembly, shall be abrogated and of no further force and effect.
