1 AN ACT concerning

2 **Maryland State Board of Contract Appeals – Positions – Law Clerks**

3 FOR the purpose of requiring the Maryland State Board of Contract Appeals to employ a
4 certain number of law clerks; providing that the Appeals Board has at least a certain
5 number of positions more than the number of positions authorized in a certain fiscal
6 year; and generally relating to the staff of the Maryland State Board of Contract
7 Appeals.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article – State Finance and Procurement**

16 15–209.

17 (a) Each member of the Appeals Board shall devote full time to the duties of office.

18 (b) Each member of the Appeals Board is entitled to:

1 (1) compensation in accordance with the State budget; and

2 (2) reimbursement for expenses under the Standard State Travel
3 Regulations, as provided in the State budget.

4 (c) (1) [The] **SUBJECT TO PARAGRAPHS (2) AND (3) OF THIS SUBSECTION,**
5 **THE Appeals Board may employ a staff in accordance with the State budget.**

6 (2) **THE APPEALS BOARD SHALL HAVE AT LEAST THREE MORE**
7 **POSITIONS THAN THE NUMBER OF POSITIONS AUTHORIZED IN FISCAL YEAR 2022.**

8 (3) (I) **SUBJECT TO SUBPARAGRAPH (II) OF THIS PARAGRAPH, THE**
9 **APPEALS BOARD SHALL EMPLOY AT LEAST THREE LAW CLERKS.**

10 (II) **THE APPEALS BOARD SHALL EMPLOY:**

11 1. **AT LEAST ONE LAW CLERK WHO IS A GRADUATE OF**
12 **THE UNIVERSITY OF MARYLAND SCHOOL OF LAW;**

13 2. **AT LEAST ONE LAW CLERK WHO IS A GRADUATE OF**
14 **THE UNIVERSITY OF BALTIMORE SCHOOL OF LAW; AND**

15 3. **AT LEAST ONE LAW CLERK WHO IS A GRADUATE OF**
16 **HOWARD UNIVERSITY SCHOOL OF LAW.**

17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June
18 1, 2022.
