1 AN ACT concerning

2 **Education Support Professionals – ~~Workgroup and Bonus~~ Bonus and Report**

3 FOR the purpose of ~~establishing the Workgroup to Study the Wages of Education Support~~
4 ~~Professionals~~; requiring the Governor to include in the annual budget bill an
5 appropriation sufficient to provide a certain bonus to certain public school employees
6 in a certain fiscal year; requiring the State Department of Education to collect
7 certain data from each county board of education for a certain school year and to
8 report the data on or before a certain date; and generally relating to ~~the study of the~~
9 ~~wages of, and the payment of a bonus to,~~ education support professionals.

10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

11 That:

12 (a) ~~There is a Workgroup to Study the Wages of Education Support Professionals.~~

13 (b) ~~The purpose of the Workgroup is to determine what percentage of education~~
14 ~~support professionals in the State earn a living wage and to study increasing the wages of~~
15 ~~education support professionals to attract and retain skilled workers.~~

16 (c) ~~The Workgroup consists of the following members:~~

17 (1) ~~two members of the Senate of Maryland, appointed by the President of~~
18 ~~the Senate;~~

~~(6) the President of the American Federation of State, County and Municipal Employees Local 2250, or the President's designee;~~

~~(d) The Workgroup shall elect the chair of the Workgroup by a majority vote at the first meeting.~~

~~(e) The Maryland State Department of Education shall provide staff for the Workgroup.~~

~~(f) A member of the Workgroup:~~

~~(1) may not receive compensation as a member of the Workgroup; but~~

~~(2) is entitled to reimbursement for expenses under the Standard State Travel Regulations, as provided in the State budget.~~

~~(g) In determining what percentage of education support professionals earn a living wage in the State and to study increasing the wages of education support professionals to attract and retain skilled workers, the Workgroup shall consider:~~

~~(1) the role of local education systems and the State in hiring education support professionals;~~

~~(2) the number of education support professionals employed by the State or a local school system, or as a contractor;~~

~~(3) any cost sharing between the State and the local school systems with regard to the wages and salaries of education support professionals;~~

1 ~~(4) the total number of part-time and full-time education support~~
2 ~~professionals in the State;~~

3 ~~(5) the number of hours required to work, according to the policies of each~~
4 ~~jurisdiction, to be considered a full-time employee;~~

5 ~~(6) a complete list of education support professional classifications by~~
6 ~~jurisdiction;~~

7 ~~(7) the average hourly wage of education support professionals in the State~~
8 ~~and by jurisdiction;~~

9 ~~(8) an analysis of the wage scale for education support professionals;~~

10 ~~(9) information on increased wages or bonuses by jurisdiction within the~~
11 ~~last 5 years;~~

12 ~~(10) the amount of vacancies in the State and by jurisdiction for education~~
13 ~~support professional jobs; and~~

14 ~~(11) information on the future of education support professional jobs in the~~
15 ~~State.~~

16 ~~(h) (1) On or before November 30, 2022, the Workgroup shall submit an~~
17 ~~interim report of its findings and recommendations to, in accordance with § 2-1257 of the~~
18 ~~State Government Article, the Senate Budget and Taxation Committee, the Senate~~
19 ~~Education, Health, and Environmental Affairs Committee, the House Appropriations~~
20 ~~Committee, and the House Committee on Ways and Means.~~

21 ~~(2) On or before August 31, 2023, the Workgroup shall submit a final report~~
22 ~~of its findings and recommendations, in accordance with § 2-1257 of the State Government~~
23 ~~Article, to the Senate Budget and Taxation Committee, the Senate Education, Health, and~~
24 ~~Environmental Affairs Committee, the House Appropriations Committee, and the House~~
25 ~~Committee on Ways and Means.~~

26 ~~SECTION 2. AND BE IT FURTHER ENACTED, That:~~

27 (a) ~~If the fiscal year 2023 budget includes an appropriation sufficient to provide a~~
28 ~~\$500 bonus to each noncertificated education support professional in fiscal year 2023, the~~
29 In this section, “noncertificated education support professionals” means noncertificated
30 public school employees designated as part of a bargaining unit under Title 6, Subtitle 5 of
31 the Education Article.

32 (b) The Governor shall include in the annual budget bill for fiscal year 2024 an
33 appropriation sufficient equal to the number of noncertificated education support
34 professionals, collected in accordance with subsection (c) of this section, multiplied by \$500,

1 in order to provide a \$500 bonus to each noncertificated education support professional in
 2 fiscal year 2024.

3 ~~(b) If the fiscal year 2023 budget does not include an appropriation sufficient to~~
 4 ~~provide a \$500 bonus to each noncertificated education support professional in fiscal year~~
 5 ~~2023, the Governor shall include in the annual budget bill for fiscal year 2024 an~~
 6 ~~appropriation sufficient to provide a \$1,000 bonus to each noncertificated education support~~
 7 ~~professional in fiscal year 2024.~~

8 (c) The State Department of Education shall:

9 (1) collect data from each county board of education, including Baltimore
 10 City, on the number of noncertificated education support professionals the county board
 11 employed during the 2021–2022 school year; and

12 (2) on or before September 15, 2022, submit a report to the Governor, the
 13 Department of Budget and Management, and the General Assembly, in accordance with §
 14 2–1257 of the State Government Article, on the total number of noncertificated education
 15 support professionals employed by county boards of education during the 2021–2022 school
 16 year.

17 SECTION ~~2~~ 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
 18 July 1, 2022. ~~Section 1 of this Act shall remain effective for a period of 1 year and 4~~
 19 ~~months and, at the end of October 31, 2023, Section 1 of this Act, with no further action~~
 20 ~~required by the General Assembly, shall be abrogated and of no further force and effect.~~
