# 2 Blueprint for Maryland's Future – Implementation Plans and Fund – Alterations

- 3 FOR the purpose of expanding the uses for certain grants under the Concentration of Poverty Grant Program; requiring the State Department of Education to collect 4  $\mathbf{5}$ certain data and submit a certain report on or before a certain date; altering certain 6 dates for the development, adoption, and submission of certain plans to implement 7the Blueprint for Maryland's Future; altering the date by which criteria to evaluate 8 certain implementation plans must be developed; requiring the Accountability and 9 Implementation Board to release certain funds withheld from a local school system 10 for a certain fiscal year if a certain condition is met; altering the distribution of 11 certain sales and use tax revenues to the Blueprint for Maryland's Future Fund; 12authorizing certain entities or programs to retain the unspent portion of a certain 13 appropriation for a certain fiscal year; and generally relating to the Blueprint for 14 Maryland's Future.

implement the Blueprint for Maryland's Future, considering any input provided by
interested stakeholders in the State.

(2) The Comprehensive Implementation Plan shall include a timeline for
implementation of the Blueprint for Maryland's Future with key milestones to be achieved
by each State or local government unit required to implement an element of the Blueprint
for Maryland's Future for each year of the implementation period.

(3) The Comprehensive Implementation Plan shall include the intended
 outcomes that the Blueprint for Maryland's Future will achieve.

1 (4) (i) The Comprehensive Implementation Plan shall be adopted by 2 the Board no later than [February 15, 2022] **DECEMBER 1, 2022**.

3 (ii) Any changes to the Comprehensive Implementation Plan shall
4 be adopted by the Board no later than August 1 of each year.

5 (b) (1) The Board shall adopt guidelines for entities required to submit and 6 carry out implementation plans under this section that include establishing a maximum 7 page length, including appendices, for implementation plans.

AND BE IT FURTHER ENACTED, That any entity or program that 8 receives a supplementary appropriation under Section 6 of Chapter 356 of the Acts of the 9 General Assembly of 2021 may retain any special funds received for the implementation of 10 the Blueprint for Maryland's Future, as defined in § 5–401 of the Education Article, that 11 were not spent in fiscal year 2022.
