## Pharmacists – Aids for the Cessation of Tobacco Product Use

- FOR the purpose of authorizing a pharmacist who meets the requirements of regulations adopted by the State Board of Pharmacy to prescribe and dispense nicotine replacement therapy medications approved by the U.S. Food and Drug Administration as aids for the cessation of the use of tobacco products; and generally relating to the prescribing and dispensing of aids for the cessation of the use of tobacco products.

- 26 (II) THE CONDITIONS UNDER WHICH A PHARMACIST MAY
- 27 PRESCRIBE AND DISPENSE AN AID FOR THE CESSATION OF THE USE OF TOBACCO

- 29 (2) THE REGULATIONS SHALL REQUIRE A PHARMACIST TO:

- 5 REFER THE PATIENT FOR ANY ADDITIONAL CARE TO 6 THE PATIENT'S PRIMARY CARE PRACTITIONER;
- 7 PROVIDE THE PATIENT WITH:
- 8 A. A WRITTEN RECORD OF THE MEDICATION

- B. Information on the importance of the patient

- 16 COMPLETE THE TRAINING PROGRAM UNDER PARAGRAPH (2)(I) OF THIS
- 17 SUBSECTION FOR A PHARMACIST WHO ALREADY HAS UNDERGONE THE TRAINING AS
- 18 PART OF THE PHARMACIST'S FORMAL EDUCATIONAL PROGRAM.
