1 AN ACT concerning

2 **Children – Therapeutic Child Care Program – Funding**

3 FOR the purpose of establishing the Therapeutic Child Care Program to provide specialized
4 child care and early childhood education by educators, early intervention providers,
5 mental health providers, and health care providers to children under a certain age
6 who have delays in development, physical disabilities, or delays in social, emotional,
7 or behavioral functioning; and generally relating to the Therapeutic Child Care
8 Program.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
15 That the Laws of Maryland read as follows:

16 **Article – Education**

17 **8–420.**

18 **(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS**
19 **INDICATED.**

1 **(2) “DEVELOPMENTAL DELAYS, PHYSICAL DISABILITIES, OR DELAYS**
2 **IN SOCIAL, EMOTIONAL, OR BEHAVIORAL FUNCTIONING” MEANS:**

3 **(I) A SIGNIFICANT DEVELOPMENTAL DELAY OR ATYPICAL**
4 **DEVELOPMENT, AS IDENTIFIED BY A HEALTH PROFESSIONAL, IN:**

- 5 1. **COGNITIVE DEVELOPMENT;**
- 6 2. **PHYSICAL DEVELOPMENT;**
- 7 3. **LANGUAGE AND SPEECH DEVELOPMENT;**
- 8 4. **PSYCHOSOCIAL DEVELOPMENT; OR**
- 9 5. **SELF-HELP SKILLS;**

10 **(II) PSYCHOLOGICAL TRAUMA, AS IDENTIFIED THROUGH AN**
11 **EVALUATION BY A MENTAL HEALTH PROFESSIONAL; OR**

12 **(III) A DIAGNOSED PHYSICAL, DEVELOPMENTAL, OR MENTAL**
13 **HEALTH CONDITION THAT IMPACTS DAILY LIVING AND LIMITS PARTICIPATION IN**
14 **TYPICAL EARLY CHILDHOOD EDUCATION OR CHILD CARE SETTINGS.**

15 **(3) “PROGRAM” MEANS THE THERAPEUTIC CHILD CARE PROGRAM.**

16 **(B) THERE IS A THERAPEUTIC CHILD CARE PROGRAM IN THE STATE.**

17 **(C) THE PURPOSE OF THE PROGRAM IS TO PROVIDE SPECIALIZED CHILD**
18 **CARE AND EARLY CHILDHOOD EDUCATION BY EDUCATORS, EARLY INTERVENTION**
19 **PROVIDERS, MENTAL HEALTH PROVIDERS, AND HEALTH CARE PROVIDERS TO**
20 **CHILDREN UNDER THE AGE OF 6 YEARS WHO HAVE:**

- 21 **(1) DEVELOPMENTAL DELAYS;**
- 22 **(2) PHYSICAL DISABILITIES; OR**
- 23 **(3) DELAYS IN SOCIAL, EMOTIONAL, OR BEHAVIORAL FUNCTIONING.**

24 **(D) (1) SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, FOR FISCAL**
25 **YEAR 2024, THE GOVERNOR SHALL INCLUDE IN THE ANNUAL BUDGET BILL AN**
26 **APPROPRIATION TO THE PROGRAM IN AN AMOUNT NOT LESS THAN THE PER PUPIL**
27 **FUNDING AMOUNT OF \$45,000 FOR EACH CHILD SERVED WHO HAS DEVELOPMENTAL**

1 DELAYS, PHYSICAL DISABILITIES, OR DELAYS IN SOCIAL, EMOTIONAL, OR
2 BEHAVIORAL FUNCTIONING.

3 **(2) (I) FOR FISCAL YEAR 2024, FOR PROVIDERS IN THE PROGRAM**
4 **THAT BEGAN PROVIDING CARE TO CHILDREN ON OR BEFORE MARCH 5, 2020, THE**
5 **PER PUPIL FUNDING AMOUNT SHALL BE CALCULATED USING THE HIGHER OF:**

6 **1. THE JANUARY 1, 2019, ENROLLMENT; OR**

7 **2. THE JANUARY 1, 2023, ENROLLMENT.**

8 **(II) FOR FISCAL YEAR 2024, FOR PROVIDERS IN THE PROGRAM**
9 **THAT BEGAN PROVIDING CARE TO CHILDREN AFTER MARCH 5, 2020, THE PER PUPIL**
10 **FUNDING AMOUNT SHALL BE CALCULATED USING THE JANUARY 1, 2023,**
11 **ENROLLMENT.**

12 **(3) BEGINNING IN FISCAL YEAR 2025 AND EACH FISCAL YEAR**
13 **THEREAFTER, THE GOVERNOR SHALL INCREASE THE PER PUPIL FUNDING AMOUNT**
14 **UNDER PARAGRAPH (1) OF THIS SUBSECTION BY THE LESSER OF:**

15 **(I) THE CONSUMER PRICE INDEX FOR ALL URBAN**
16 **CONSUMERS FOR THE WASHINGTON METROPOLITAN AREA, OR ANY SUCCESSOR**
17 **INDEX; OR**

18 **(II) 1.5%.**

19 **(4) THE PROGRAM MAY BE FUNDED FROM:**

20 **(I) THE GENERAL FUND OF THE STATE; AND**

21 **(II) ANY OTHER SOURCES.**

22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
23 1, 2022.
