1 AN ACT concerning

2 Procurement – Construction Contracts – Contract Modification Clause – Report

FOR the purpose of requiring a procurement contract for construction to include a clause
providing for contract modification when there is a substantial increase in the price
of materials required to complete the contract, as determined by the unit, due to
certain factors; requiring the Secretary of Transportation and the Secretary of
General Services to review certain State contracts and report findings regarding
contract modifications related to the price of materials; and generally relating to
contract modifications for construction contracts.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
