5 (A) EACH YEAR, THE DIVISION SHALL ISSUE A REQUEST FOR APPLICATIONS 6 FROM ELIGIBLE EMPLOYERS FOR MATCHING GRANTS OFFERED UNDER THE 7 PROGRAM.

8 (B) TO RECEIVE A MATCHING GRANT UNDER THE PROGRAM, AN ELIGIBLE 9 EMPLOYER SHALL SUBMIT TO THE DIVISION AN APPLICATION WHICH SHALL 10 INCLUDE:

11 (1) A LIST OF TRAINING PROGRAMS THAT HEALTH CARE WORKERS 12 HAVE REQUESTED TO ATTEND DURING THE IMMEDIATELY FOLLOWING CALENDAR 13 YEAR;

14(2) THE COST OF ANY TRAINING PROGRAMS THAT HEALTH CARE15WORKERS HAVE REQUESTED TO ATTEND DURING THE IMMEDIATELY FOLLOWING16CALENDAR YEAR AND FOR WHICH AN ELIGIBLE EMPLOYER HAS AGREED TO PAY;

17 (3) SUFFICIENT DETAIL ABOUT A TRAINING PROGRAM TO ALLOW THE
 18 DIVISION TO ENSURE THAT THE TRAINING PROGRAM MEETS THE REQUIREMENTS
 19 OF THIS SUBTITLE; AND

20(4) AN ASSURANCE THAT THE TRAINING PROGRAM SHALL BE21PROVIDED AT NO COST TO A HEALTH CARE WORKER.

(A) IN EVALUATING THE APPLICATIONS SUBMITTED UNDER § 11–1504 OF
THIS SUBTITLE AND SELECTING ELIGIBLE EMPLOYERS TO RECEIVE A MATCHING
GRANT UNDER THE PROGRAM, THE DIVISION SHALL SECURE MATCHING CASH
CONTRIBUTIONS OR OTHER CONSIDERATION FOR TRAINING PROGRAMS DURING
THE IMMEDIATELY FOLLOWING CALENDAR YEAR IN AN AMOUNT AT LEAST EQUAL IN
VALUE TO THE AMOUNT REQUESTED FROM THE PROGRAM.

29 (B) (1) THE DIVISION MAY NOT AWARD A MATCHING GRANT THAT 30 EXCEEDS \$50,000 EACH YEAR TO AN ELIGIBLE EMPLOYER.

31(2)IF THE DIVISION RECEIVED APPLICATIONS FOR MATCHING32GRANTS TOTALING MORE THAN THE AMOUNT OF FUNDS APPROPRIATED FOR THE

PROGRAM FOR A FISCAL YEAR, THE DIVISION SHALL AWARD THE GRANTS ON A PRO
 RATA BASIS.

3 (C) A MATCHING GRANT AWARDED UNDER THE PROGRAM SHALL BE VALID 4 FOR 1 CALENDAR YEAR.

5 (D) AN ELIGIBLE EMPLOYER RECEIVING A MATCHING GRANT UNDER THE 6 PROGRAM SHALL USE THE GRANT TO SUPPLEMENT, AND NOT SUPPLANT, THE 7 AMOUNT OF FUNDS THAT, IN THE ABSENCE OF THE GRANT, WOULD BE AVAILABLE 8 TO PAY FOR THE TRAINING PROGRAMS TO BE ATTENDED BY HEALTH CARE WORKERS 9 DURING THE IMMEDIATELY FOLLOWING CALENDAR YEAR.

10 (E) AN ELIGIBLE EMPLOYER RECEIVING A GRANT UNDER THE PROGRAM 11 SHALL PROVIDE A 10% WAGE INCREASE TO A HEALTH CARE WORKER WHO 12 COMPLETES A TRAINING PROGRAM FOR WHICH A GRANT HAS BEEN AWARDED 13 UNDER THE PROGRAM.

14 **(F)** IF AN ELIGIBLE EMPLOYER AND AN EMPLOYEE ORGANIZATION OR 15 UNION BARGAIN COLLECTIVELY TO CREATE A TRAINING AND UPGRADING FUND 16 THAT BENEFITS HEALTH CARE WORKERS, ANY GRANT MONEY AWARDED UNDER THE 17 PROGRAM SHALL PASS THROUGH THE FUND.

19 (A) FOR EACH FISCAL YEAR, THE GOVERNOR SHALL INCLUDE IN THE 20 ANNUAL BUDGET BILL AN APPROPRIATION OF AT LEAST \$1,000,000 FOR THE 21 PROGRAM.

(B) APPROPRIATIONS AND EXPENDITURES MADE FOR THE PURPOSE OF IMPLEMENTING THE PROGRAM, INCLUDING THE USE OF ANY FUNDS RECEIVED BY A PERSON UNDER ANY COMPONENT OF THE PROGRAM, ARE SUBJECT TO AUDIT BY THE OFFICE OF LEGISLATIVE AUDITS AS PROVIDED IN § 2–1220 OF THE STATE GOVERNMENT ARTICLE.

27 **11–1507.**

(A) ON OR BEFORE DECEMBER 1 EACH YEAR, BEGINNING IN 2023, THE
DIVISION SHALL REPORT TO THE SENATE FINANCE COMMITTEE AND THE HOUSE
HEALTH AND GOVERNMENT OPERATIONS COMMITTEE, IN ACCORDANCE WITH §
2–1257 OF THE STATE GOVERNMENT ARTICLE, ON:

32(1) THE AMOUNT OF GRANT FUNDS PROVIDED TO ELIGIBLE33EMPLOYERS FOR TRAINING PROGRAMS DURING THE REPORTING PERIOD;

1 (2) THE NUMBER OF HEALTH CARE WORKERS WHO ATTENDED 2 TRAINING PROGRAMS FOR WHICH GRANT FUNDS WERE USED DURING THE 3 REPORTING PERIOD; AND

4 (3) THE HBCUS OR COMMUNITY COLLEGES WHICH PROVIDED 5 TRAINING PROGRAMS TO HEALTH CARE WORKERS AND FOR WHICH GRANT FUNDS 6 WERE USED DURING THE REPORTING PERIOD.

7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 8 October 1, 2022.
