5 FOR the purpose of requiring the Maryland Higher Education Commission to focus on
6 certain individuals in the near completer communication campaign for certain
7 academic years; requiring the ~~Maryland Higher Education~~ Commission to use a
8 certain annual family income determination when awarding a Guaranteed Access
9 Grant; authorizing the Next Generation Scholars of Maryland Program to continue
10 providing certain services to students when they attend an institution of higher
11 education; ~~altering the maximum award amount for an Educational Assistance~~
12 ~~Grant;~~ providing that a recipient of a Guaranteed Access Grant who becomes
13 ineligible because of a change in family income shall remain eligible for the full
14 award term applicable to the recipient ~~with a reduced award amount calculated by~~
15 ~~the Commission; requiring the Governor to include in the annual budget bill a~~
16 ~~certain appropriation for Delegate Howard P. Rawlings Educational Excellence~~

24 Educational Excellence Awards, and the Edward T. Conroy and Jean B. Cryor

21 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
22 That the Laws of Maryland read as follows:

23 **Article – Education**

24 11–209.

25 (a) In this section, “near completer” means an individual who has completed some
26 college credits but does not have a college degree and is no longer attending an institution
27 of higher education.

28 (b) (1) (i) The Commission, in collaboration with institutions of higher
29 education, shall create a statewide communication campaign to identify near completers in
30 the State and to encourage near completers to re-enroll in an institution of higher
31 education to earn a degree.

32 (ii) For each of fiscal years 2020 through 2024, the Governor shall
33 include in the State budget \$125,000 to the Commission to fund a statewide communication
34 campaign.

35 (2) The communication campaign shall:

1 (i) Make use of a variety of marketing media, including billboards,
2 brochures, and electronic resources;

3 (ii) Provide a centralized contact point for near completers to get
4 information about and assistance with re-enrolling;

5 (iii) Make readily available contact information for each public
6 institution of higher education in the State; [and]

7 (iv) Focus on near completers who:

8 1. Earned a minimum grade point average of 2.0 on a scale
9 of 4.0 while in college; and

10 2. A. Earned at least 45 credit hours if the individual
11 attended a community college; or

12 B. Earned at least 90 credit hours if the individual attended
13 a senior higher education institution; AND

14 **(V) FOR THE 2022–2023 AND 2023–2024 ACADEMIC YEARS,**
15 **FOCUS ON NEAR COMPLETERS WHO ARE NO LONGER ATTENDING AN INSTITUTION**
16 **OF HIGHER EDUCATION BECAUSE OF PERSONAL OR FINANCIAL REASONS RELATED**
17 **TO THE COVID–19 PANDEMIC.**

19 (c) “Program” means the Maryland Higher Education Outreach and College
20 Access Program.

22 **(A) For fiscal year 2023 [and each fiscal year thereafter], the Governor shall**
23 **include in the annual budget bill an appropriation of \$200,000 for the Program.**

24 **(B) FOR FISCAL YEAR 2024 AND EACH FISCAL YEAR THEREAFTER, THE**
25 **GOVERNOR SHALL INCLUDE IN THE ANNUAL BUDGET BILL AN APPROPRIATION OF**
26 **\$500,000 FOR THE PROGRAM.**

28 (a) Subject to subsection (e) of this section, each recipient of a Delegate Howard
29 P. Rawlings Educational Excellence Award shall:

30 (3) Demonstrate a definite financial need to:

1 (i) For an Educational Assistance Grant, the Office; or

2 (ii) For a Guaranteed Access Grant, the Office or an institution of
3 higher education that complies with § 18–303.3 of this subtitle; and

4 (b) Except as provided in subsection (c) of this section, each recipient of a
5 Guaranteed Access Grant shall:

6 (6) Subject to subsection (d) of this section, have an annual family income
7 below a poverty index determined by the Commission; and

8 (c) (1) Subject to paragraph (2) of this subsection, an individual who has
9 successfully obtained a high school diploma by examination under § 11–808 of the Labor
10 and Employment Article is exempt from the requirements of subsection (b) of this section.

11 (2) An individual described under paragraph (1) of this subsection is
12 eligible for a Guaranteed Access Grant if the individual:

13 (v) Subject to subsection (d) of this section, has an annual family
14 income below a poverty index determined by the Commission.

15 (d) (1) To determine the annual family income eligibility of an applicant for a
16 Guaranteed Access Grant, the Office or an institution of higher education that complies
17 with § 18–303.3 of this subtitle may not consider an amount received by the applicant as
18 an earned income credit under § 32 of the Internal Revenue Code.

19 (2) **WHEN AWARDING A GUARANTEED ACCESS GRANT TO A STUDENT**

24 (e) (1) Except as provided in paragraph (2) of this subsection, a student in
25 grade 7 or grade 8 who applies and qualifies for a Guaranteed Access Grant on the basis of
26 financial need as established by the Commission shall prequalify for a Guaranteed Access
27 Grant to be used at the time of enrollment in an institution of higher education by agreeing
28 in writing, as a secondary and undergraduate student, to:

29 (i) Satisfy the attendance policy of the applicable school;

30 (ii) Refrain from substance abuse;

31 (iii) Provide information required by the Commission or the State
32 Board of Education;

1 (iv) Apply for admission to an institution of higher education during
2 the student's senior year of high school;

3 (v) Complete and file on a timely basis applications for federal
4 student aid for each year that the student plans to enroll in postsecondary education;

5 (vi) Participate in the Next Generation Scholars of Maryland
6 Program established in § 18–303.1 of this subtitle until the student graduates from high
7 school and matriculates at an institution of higher education;

8 (vii) Maintain a cumulative grade point average of at least 2.5 on a
9 4.0 scale or its equivalent; and

10 (viii) Satisfy any other program requirements set by the Office, the
11 Commission, the State Board of Education, or the State Department of Education.

12 (2) A student in grade 9 or grade 10 shall prequalify for a Guaranteed
13 Access Grant to be used at the time of enrollment in an institution of higher education if
14 the student:

15 (i) Otherwise meets the conditions of paragraph (1) of this
16 subsection; and

17 (ii) 1. Is eligible for free or reduced priced meals; or
18 2. Attends a school that participates in the U.S. Department
19 of Agriculture Community Eligibility Provision and the student is identified by:

20 A. Direct certification; or

21 B. Income information provided by the family of the student
22 to the local school system on an alternative form developed by the Department.

24 (a) (1) In this section the following words have the meanings indicated.

25 (2) “Fund” means the Next Generation Scholars of Maryland Program
26 Fund.

27 (3) “Program” means the Next Generation Scholars of Maryland Program.

28 (c) The Program shall provide guidance and services to students who qualify for
29 a Guaranteed Access Grant in accordance with § 18–303(e) of this subtitle to assist the
30 students in successfully:

31 (1) Completing a college preparatory curriculum;

1 (2) Graduating from high school;

2 (3) Matriculating at an institution of higher education as defined in §
3 18–303 of this subtitle; and

4 (4) Making timely progress to complete a degree program.

5 (d) (1) The Department shall:

6 [(1)] (I) Publicize the Program through community outreach and
7 marketing materials;

8 [(2)] (II) Award grants to nonprofit organizations to administer the
9 Program;

10 [(3)] (III) Solicit applications from nonprofit organizations to administer
11 the Program in local school systems; and

12 [(4)] (IV) Give priority to applications:

13 [(i)] 1. From Maryland–based nonprofit organizations; and

14 [(ii)] 2. That include business and institution of higher education
15 partners.

18 (e) In accordance with subsection (c) of this section, the services to be provided to
19 students participating in the Program shall include:

20 (1) A high school graduation plan;

21 (2) Summer work or internship opportunities;

22 (3) Financial aid literacy assistance;

23 (4) Career interest assessments;

24 (5) Mentorship and one–on–one counseling;

25 (6) Visits to college campuses and workplaces;

26 (7) An intensive summer bridge or matriculation assistance program for
27 students entering an institution of higher education directly from high school; and

1 (8) A plan to matriculate and graduate from an institution of higher
2 education.

22 **THIS PARAGRAPH, THE** amount of a Guaranteed Access Grant made to a student in the
23 student's first 2 academic years of enrollment shall be equal to 100 percent of the student's
24 financial need as determined by the Office, not to exceed the equivalent annual expenses
25 of a full-time resident undergraduate at the 4-year public institution of higher education
26 within the University System of Maryland, other than the University of Maryland Global
27 Campus and University of Maryland, Baltimore Campus, with the highest annual expenses
28 for a full-time resident undergraduate.

29 **(iii) [Beginning] EXCEPT AS PROVIDED IN SUBPARAGRAPH (IV)**
30 **OF THIS PARAGRAPH, BEGINNING** in the third academic year of enrollment and for each
31 academic year thereafter:

32 1. If the student successfully completed at least 30 credits in
33 the prior academic year, the award amount shall be equal to 100 percent of the student's
34 financial need as determined by the Office, not to exceed the equivalent annual expenses
35 of a full-time resident undergraduate at the 4-year public institution of higher education

1 within the University System of Maryland, other than the University of Maryland Global

 5 than 30 credits in the prior academic year, the award amount shall be equal to 100 percent
 6 multiplied by the ratio of the number of credits successfully completed divided by 30.

19 (a) (1) In this section the following words have the meanings indicated.

20 (2) “Disabled public safety employee” means a State or local public safety
 21 employee who sustains an injury in the line of duty that:

22 (i) Precludes the individual from continuing to serve or be employed
 23 as a State or local public safety employee; and

24 (ii) In the case of a volunteer member of a fire department or
 25 ambulance or rescue company or squad, precludes the member from continuing to be
 26 employed in the nonpublic safety occupation in which the member is engaged at the time
 27 of the injury.

28 (3) “Fund” means the Edward T. Conroy and Jean B. Cryor Scholarship
 29 Fund.

30 (4) “School employee” includes an employee of a public or nonpublic school
 31 in the State.

32 (5) “State or local public safety employee” means a person who is employed
 33 in the State as:

34 (i) A career or volunteer member of a:

1 1. Fire department;

2 2. Ambulance company or squad; or

3 3. Rescue company or squad;

4 (ii) A law enforcement officer;

5 (iii) A correctional officer; or

6 (iv) A member of the Maryland National Guard who was a resident
7 of this State at the time of death.

8 (6) “Surviving spouse” means a person who has not remarried.

9 (7) “Victim of the September 11, 2001, terrorist attacks” means a Maryland
10 resident who was killed as a result of the attacks on the World Trade Center in New York
11 City, the attack on the Pentagon in Virginia, or the crash of United Airlines Flight 93 in
12 Pennsylvania.

13 (b) There is a program of scholarships that are awarded by eligible postsecondary
14 institutions under this section.

15 (c) (1) The program for military and public safety personnel and their eligible
16 dependents is the Edward T. and Mary A. Conroy Memorial Scholarship Program.

17 (2) The program for eligible dependents of public and nonpublic school
18 employees is the Jean B. Cryor Memorial Scholarship Program.

19 (d) (1) A person may apply to an eligible postsecondary institution for a
20 scholarship under this section if the person:

21 (i) 1. Is accepted for admission or enrolled in the regular
22 undergraduate, graduate or professional program at an eligible institution; [or]

23 2. Is enrolled in a 2-year terminal certificate program in
24 which the course work is acceptable for transfer credit for an accredited baccalaureate
25 program in an eligible institution; OR

26 **3. IS ENROLLED IN A PRIVATE CAREER SCHOOL;**

27 (ii) Is at least 16 years old; and

28 (iii) Meets the other eligibility criteria specified in this section.

1 (f) (1) Each postsecondary institution shall determine the eligibility of
2 persons who apply to the institution for the Edward T. Conroy Memorial Scholarship
3 Program and the Jean B. Cryor Memorial Scholarship Program.

4 (2) Funds for the Edward T. Conroy Memorial Scholarship Program and
5 the Jean B. Cryor Memorial Scholarship Program shall be allocated by the Commission to
6 each postsecondary institution based on the number of eligible recipients attending each
7 institution.

8 (3) In October and February of each year, each postsecondary institution
9 shall report to the Commission the number of eligible recipients attending the institution.

10 (4) The Commission shall allocate funds for awards to postsecondary
11 institutions upon verification of eligible recipients attending the institutions.

12 (5) If funds cannot be allocated in the fiscal year in which awards are made,
13 priority shall be given to allocating funds for those awards in the following fiscal year.

14 **(I) FOR FISCAL YEAR 2024 AND EACH FISCAL YEAR THEREAFTER, THE**
15 **GOVERNOR SHALL INCLUDE IN THE ANNUAL BUDGET BILL AN APPROPRIATION OF**
16 **AT LEAST \$4,000,000 TO THE FUND.**

18 (a) For purposes of this section, an individual served in the Afghanistan or Iraq
19 conflict if the individual was a member of the uniformed services of the United States who
20 served in:

21 (1) Afghanistan or contiguous air space, as defined in federal regulations,
22 on or after October 24, 2001, and before a terminal date to be prescribed by the United
23 States Secretary of Defense; or

24 (2) Iraq or contiguous waters or air space, as defined in federal regulations,
25 on or after March 19, 2003, and before a terminal date to be prescribed by the United States
26 Secretary of Defense.

27 (b) There is a Veterans of the Afghanistan and Iraq Conflicts Scholarship.

28 (c) An individual may apply to the Office for a scholarship under this section if
29 the individual:

30 (1) Is a resident of Maryland;

31 (2) (i) Is accepted for admission or enrolled in the regular
32 undergraduate program at an eligible institution; or

1 (ii) Is accepted for admission or enrolled in a 2-year terminal
2 certificate program in which the course work is acceptable for transfer credit for an
3 accredited baccalaureate program in an eligible institution; and

4 (3) (i) 1. Is a veteran, as defined under § 9-901 of the State
5 Government Article, who served in the Afghanistan or Iraq conflict;

6 2. Is an active duty member of the armed forces who served
7 in the Afghanistan or Iraq conflict; or

8 3. Is a member of a reserve component of the armed forces of
9 the United States or the Maryland National Guard who was activated as a result of the
10 Afghanistan or Iraq conflict described in subsection (a) of this section; or

11 (ii) Is a son, daughter, STEPSON, STEPDAUGHTER, or spouse of:

12 1. A veteran or active duty member of the armed forces who
13 is serving or has served in the Afghanistan or Iraq conflict; or

14 2. A member of the reserve or Maryland National Guard who
15 was activated as a result of the Afghanistan or Iraq conflict described in subsection (a) of
16 this section.

18 There is a James Proctor Scholarship Program in the State.

20 (a) The Governor [may] SHALL include in the [State] ANNUAL budget BILL an
21 appropriation OF AT LEAST \$400,000 [for scholarships under] TO the Program FOR
22 SCHOLARSHIP AWARDS.

23 (b) These funds appropriated under subsection (a) of this section shall be divided
24 and distributed equally to each HBCU.

26 To qualify for a 2+2 Transfer Scholarship, an applicant shall:

27 (10) Have demonstrated financial need, defined [as a federally calculated
28 expected family contribution (EFC) of \$10,000 or less as reported on the student's FAFSA]
29 BY THE COMMISSION; and

30 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
31 1, 2022.
