AMENDMENT NO. 1

On page 1, strike beginning with "for" in line 4 down through "minor" in line 6 and substitute "applicable to sexual offense in the fourth degree"; in line 7, strike "from"; in line 8, strike "certain"; in line 9, after "enrolled" insert "at a school"; strike beginning with "the" in line 9 down through "where" in line 10 and substitute "a certain program for which"; in line 10, strike "is"; and in line 11, strike "employed or under contract;" and substitute "works; prohibiting sexual offense in the fourth degree from being considered a lesser inclusive crime of any other crime, except under certain circumstances; authorizing the imposition of a certain sentence in a certain manner;".

AMENDMENT NO. 2

On page 3, strike beginning with "<u>IN</u>" in line 3 down through "<u>GOVERNMENT</u>" in line 26 and substitute "<u>IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS INDICATED.</u>

- (2) (I) "PERSON IN A POSITION OF AUTHORITY" MEANS A PERSON WHO:
- 1. A. IS AT LEAST 21 YEARS OLD AND WORKS FOR REMUNERATION OR AS A VOLUNTEER FOR A PUBLIC OR PRIVATE PRESCHOOL, ELEMENTARY SCHOOL, OR SECONDARY SCHOOL; OR
- B. IS AT LEAST 22 YEARS OLD AND WORKS FOR REMUNERATION OR AS A VOLUNTEER FOR A PROGRAM; AND

2. EXERCISES SUPERVISION OVER OR WORKS OR INTERACTS WITH ONE OR MORE MINORS WHO ATTEND THE SCHOOL OR PARTICIPATE IN THE PROGRAM";

in line 27, strike "(2)" and substitute "(II)"; and strike beginning with the colon in line 27 down through "SUBSECTION," in line 29.

On pages 3 and 4, strike beginning with "<u>; AND</u>" in line 31 on page 3 down through "<u>ACTIVITY</u>" in line 9 on page 4.

On page 4, after line 9, insert:

"(3) "PROGRAM" MEANS:

- (I) AN INDIVIDUAL, A BUSINESS, A RELIGIOUS OR FAITH-BASED INSTITUTION, OR AN ORGANIZATION THAT PROVIDES, ON A FOR-PROFIT OR NONPROFIT BASIS, INSTRUCTIONAL, COACHING, RECREATIONAL, SPIRITUAL, CHARACTER-BUILDING, OR SUPERVISORY SERVICES OR ACTIVITIES FOR MINORS, INCLUDING:
- 1. SPORTS, MUSIC, DANCE, ART, OR MARTIAL ARTS COACHING OR INSTRUCTION;
 - 2. TUTORING OR ACADEMIC ENRICHMENT;
 - 3. DAY CARE OR AFTER SCHOOL CARE;
 - 4. SCOUTING; OR
 - **<u>5.</u>** DAY OR OVERNIGHT CAMPING; OR

(II) ANY UNIT OF LOCAL, STATE, OR FEDERAL GOVERNMENT.".

AMENDMENT NO. 3

On page 4, in line 19, strike the brackets; in the same line, strike the second comma; in line 20, strike ", OR VAGINAL INTERCOURSE"; in lines 21 and 22, strike "SEXUAL ACT, SEXUAL CONTACT" and substitute "sexual act or sexual contact"; in line 22, strike ", OR VAGINAL INTERCOURSE," and substitute ":

(I)";

strike beginning with "<u>, OR</u>" in line 23 down through "ACTIVITY" in line 24; in lines 24 and 25, strike "is employed **OR UNDER CONTRACT**" and substitute "<u>WORKS</u>; <u>OR</u>

(II) 1. IS PARTICIPATING IN A PROGRAM FOR WHICH THE PERSON IN A POSITION OF AUTHORITY WORKS; AND

2. <u>IS AT LEAST 6 YEARS YOUNGER THAN THE PERSON</u> IN A POSITION OF AUTHORITY";

in line 32, strike the second comma and substitute ":

<u>(I)</u>";

and in line 33, strike "is employed" and substitute "WORKS; OR

(II) 1. IS PARTICIPATING IN A PROGRAM FOR WHICH THE PERSON IN A POSITION OF AUTHORITY WORKS; AND

2. IS AT LEAST 6 YEARS YOUNGER THAN THE PERSON IN A POSITION OF AUTHORITY".

On page 5, in line 13, after "(E)" insert "(1)"; and after line 15, insert:

"(2) A SENTENCE IMPOSED UNDER THIS SECTION MAY BE IMPOSED SEPARATE FROM AND CONSECUTIVE TO OR CONCURRENT WITH A SENTENCE FOR ANY CRIME BASED ON THE ACT ESTABLISHING THE VIOLATION OF THIS SECTION.".
