AMENDMENT NO. 1

On page 1, in the sponsor line, strike "and Watson" and substitute "<u>Augustine,</u> <u>Brooks, Hester, Kagan, Lewis Young, M. Washington, and Watson</u>".

AMENDMENT NO. 2

On pages 3 and 4, strike in their entirety the lines beginning with line 21 on page 3 down through line 2 on page 4, inclusive, and substitute:

"(B) "DISABILITY" MEANS A PHYSICAL OR MENTAL IMPAIRMENT THAT SUBSTANTIALLY LIMITS A MAJOR LIFE ACTIVITY.".

On page 4, in line 7, strike "§ 4-2906(B)" and substitute "§ 4-2906".

On page 6, in line 5, after "SHALL" insert "<u>EQUALLY</u>"; in line 7, strike "16" and substitute "<u>18</u>"; in line 8, after "(2)" insert "<u>A FOSTER CHILD WHO IS UNDER THE AGE</u> <u>OF 18;</u>

<u>(3)</u>";

in lines 9, 10, and 11, strike "(3)", "(4)", and "(5)", respectively, and substitute "(4)", "(5)", and "(6)", respectively; in line 13, strike "15" and substitute "<u>30</u>"; and in line 22, strike "A PROPORTION" and substitute "<u>NOT MORE THAN 30%</u>".

On page 7, strike beginning with "IF" in line 3 down through "HOUSEHOLD" in line 4 and substitute "<u>TO PROVIDE NECESSARY SUPPORTIVE SERVICES FOR A</u> <u>FAMILY MEMBER WHO IS A PERSON WITH A DISABILITY</u>"; strike beginning with

"APPROVE" in line 5 down through "8.11" in line 7 and substitute "<u>REASONABLY</u> <u>MODIFY ITS POLICIES, PROCEDURES, AND RULES TO ALLOW A FAMILY THAT</u> <u>INCLUDES A PERSON WITH A DISABILITY TO HAVE A LIVE–IN AIDE</u>"; in line 12, strike "(I)"; in line 16, 18, and 22, strike "(II)", "(2)", and "(3)", respectively, and substitute "(2)", "(B)", and "(C)", respectively; in line 16, after "ON" insert "<u>OR</u> <u>BEFORE</u>"; and strike in their entirety lines 25 through 29, inclusive.

On page 8, strike line 8 in its entirety; in lines 9, 10, 11, and 13, strike "(II)", "(III)", "(IV)", and "(V)", respectively, and substitute "(I)", "(III)", "(III)", and "(IV)", respectively; in lines 16 and 17, strike ":

(I)";

strike beginning with the semicolon in line 19 down through "CRIME" in line 21; and in line 24, strike "IN A FAMILY" and substitute "<u>RESIDING IN A UNIT RENTED USING</u> <u>ASSISTANCE FROM THE STATE PROGRAM</u>".

On page 9, in line 17, after "INFORMATION;" insert "<u>AND</u>"; in line 19, strike the semicolon and substitute a period; strike in their entirety lines 20 through 23, inclusive; in line 24, strike "AFTER CONSIDERING" and substitute "<u>WHEN DETERMINING THE</u> <u>DENIAL OR TERMINATION OF ASSISTANCE UNDER THE STATE PROGRAM, THE</u> <u>DEPARTMENT MAY CONSIDER</u>"; and strike beginning with the comma in line 29 down through "**PROGRAM**" in line 30, inclusive.

On page 10, in line 2, after "HOUSING" insert "<u>FOR VIOLENT CRIMINAL</u> <u>ACTIVITY THAT THREATENED THE HEALTH, SAFETY, OR WELFARE OF OTHER</u> <u>RESIDENTS</u>"; in line 10, strike the second "OR"; and in line 12, after "EMPLOYEES" insert "<u>, THE PROPERTY OWNER OR PROPERTY MANAGEMENT STAFF, OR OTHER</u> <u>RESIDENTS; OR</u>

(7) <u>RECEIVES ASSISTANCE UNDER THE STATE PROGRAM AND IS</u> <u>ABSENT FROM THE UNIT FOR MORE THAN 180 CONSECUTIVE DAYS</u>".

On page 11, in line 10, strike "HAVE A FINANCIAL INTEREST IN THE UNIT" and substitute "OWN THE UNIT THAT THE ASSISTANCE IS PROVIDED FOR"; in line 11, strike "OR"; in line 12, after "UNIT" insert "<u>; OR</u>

(4) <u>ALLOW ANYONE NOT ON THE UNIT LEASE TO RESIDE IN THE</u> <u>UNIT</u>";

and in line 21, strike "A" and substitute "AN INFORMAL".

On page 12, in line 1, strike "(A)"; in line 2, after "MAY" insert "<u>CONTINUE TO</u>"; in line 3, after "ASSISTANCE" insert "<u>IF THE HOUSEHOLD IS SOLELY OCCUPIED BY</u> <u>REMAINING FAMILY MEMBERS IN ACCORDANCE WITH THIS SUBTITLE</u>"; strike in their entirety lines 4 through 12, inclusive; and in line 27, strike "1%" and substitute "<u>6%</u>".

On page 13, in line 25, strike "4–2905(B)" and substitute "<u>4–2906</u>".

On page 14, in line 2, strike "AND"; and in line 3, after "PROGRAM" insert ";

(14) THE DISABILITY STATUS OF HOUSEHOLDS SERVED; AND

(15) THE NUMBER OF HOUSEHOLDS IN WHICH STATE PROGRAM ASSISTANCE ENDED WITHOUT THE HOUSEHOLDS HAVING RECEIVED FEDERAL HOUSING CHOICE VOUCHERS".
