- 4 (2) is certified by the Department in accordance with regulations adopted 5 under this subtitle.

- 7 [(d)] (F) "Office" means the Office for the Certified Local Farm [Enterprise] AND 8 CHESAPEAKE INVASIVE SPECIES PROVIDER Program.
