(a) 2 "QUALIFIED APPLICANT" MEANS AN AGRICULTURAL PRODUCER, A **(E)** NONPROFIT ORGANIZATION, OR AN INSTITUTION OF HIGHER EDUCATION THAT 3 MEETS THE QUALIFICATIONS ESTABLISHED IN § 2–2004 OF THIS SUBTITLE. 4 5 "Urban agricultural producer" means any person that annually sells, or 6 normally would have sold, \$1,000 or more of farm products in [Baltimore City] AN URBAN 7 AREA. "URBAN AREA" MEANS AN AREA OF THE STATE THAT IS DELINEATED AS 8 (G) 9 AN URBAN AREA BY THE U.S. CENSUS BUREAU. 10 2-2002.11 There is an Urban Agriculture Grant Program in the Department. (a) 12 The purpose of the Program is to increase the viability of urban farming and (b) 13 improve access to urban-grown foods. 14 2-2003.15 There is an Urban Agriculture Grant Fund. - 27 (3) THAT THE ENTITY WILL PROVIDE DIRECT TRAINING AND
- 28 ONGOING TECHNICAL ASSISTANCE, IN ACCORDANCE WITH A PROGRAM THAT IS
- 29 CERTIFIED BY THE U.S. DEPARTMENT OF AGRICULTURE OR THE DEPARTMENT, TO
- 30 URBAN AGRICULTURAL PRODUCERS THAT RECEIVE A GRANT UNDER THIS

- [(b)] (C) Within 90 days after the end of a grant cycle, a qualified nonprofit organization that received a grant in accordance with this subtitle shall submit a report to the Department that includes the following information:
- 4 (1) The names and locations of urban agricultural producers that received 5 funds under the Program;
- 6 (2) The dollar amount of funds awarded to each urban agricultural 7 producer; and
- 8 (3) The impact of the Program on increasing the viability of urban farming 9 and improving access to urban–grown foods.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 11 October 1, 2023.
