Video Lottery Operation License - Renewal

- 3 FOR the purpose of altering the number of years before the end of the term of a video lottery 4 operation license that a licensee is required to provide certain notice of intent to 5 renew the license and is authorized to apply for renewal; providing for the term of a 6 renewed license; requiring the State Lottery and Gaming Control Commission to 7 renew a certain license unless the Commission makes a certain finding; requiring 8 the Commission, under certain circumstances, to provide a licensee a certain hearing; requiring a licensee to pay a certain annual fee for the length of over the 9 10 course of the renewal license term under certain circumstances; and generally 11 relating to the renewal of video lottery operation licenses.



- 1 (a) The initial term of a video lottery operation license is 15 years from the date 2 on which the video lottery facility is issued the license by the Commission.
 - (b) During the initial term of a video lottery operation license, the licensee shall provide the Commission with an annual update of the information required under this subtitle for the issuance of a license by the date set by the Commission in regulations and on the form required by the Commission.
 - (c) [Two years] AT LEAST 2 YEARS BUT NOT MORE THAN 5 YEARS before the expiration of the INITIAL 15-YEAR LICENSE term OR A RENEWAL TERM of a video lottery operation license, the licensee shall file with the Commission a notice of intent to [reapply for] APPLY FOR RENEWAL OF the license under this subtitle.
- 11 (d) **(1)** This subsection applies to the first renewal of a video 12 Lottery operation license following the initial **15**-year term and each 13 Subsequent renewal of the license.
- 14 (2) A RENEWAL OF A VIDEO LOTTERY OPERATION LICENSE IS FOR A 15 TERM OF 15 YEARS.
- 16 (3) [Within 1 year of] AT LEAST 1 YEAR BUT NOT MORE THAN 5 YEARS
 17 BEFORE the end of the initial 15—year license term OR A RENEWAL TERM, a video lottery
 18 operation licensee may [reapply for a] FILE AN APPLICATION TO RENEW A VIDEO
 19 LOTTERY OPERATION license [that has a license term of 10 years and a license fee to be
 20 established by statute].
- 21 (4) ON PROPER APPLICATION FOR RENEWAL OF A VIDEO LOTTERY
 22 OPERATION LICENSE, THE COMMISSION SHALL RENEW THE LICENSE UNLESS THE
 23 COMMISSION FINDS THAT THE LICENSEE IS NO LONGER QUALIFIED UNDER THIS
 24 SUBTITLE TO HOLD A LICENSE.
- 25 (5) BEFORE DENYING AN APPLICATION UNDER THIS SUBSECTION, 26 THE COMMISSION SHALL PROVIDE THE VIDEO LOTTERY OPERATION LICENSEE AN 27 OPPORTUNITY FOR A HEARING.
- 28**(6) (I)** SUBJECT TO SUBPARAGRAPH (III) OF THIS PARAGRAPH, 29 FOR EACH YEAR OF THE RENEWAL LICENSE TERM, FOR EACH 5-YEAR PERIOD OF THE 15-YEAR TERM, THE VIDEO LOTTERY OPERATION LICENSEE SHALL PAY AN 30 ANNUAL FEE OF \$500 FOR EACH VIDEO LOTTERY TERMINAL AND EACH TABLE GAME 31 32 THAT IS AUTHORIZED FOR OPERATION A FEE EQUAL TO 1% OF THE AVERAGE 33 ANNUAL PROCEEDS FROM THE OPERATION OF VIDEO LOTTERY TERMINALS AND 34 TABLE GAMES AT THE VIDEO LOTTERY FACILITY FOR THE PRECEDING 3-YEAR PERIOD, TO BE PAID IN EQUAL ANNUAL INSTALLMENTS. 35
