17	WHEREAS, Drug addiction is a chronic disease, characterized by compulsive or
18	difficult-to-control drug use despite harmful consequences; and
19	WHEREAS, Drug addiction is seen by both the Centers for Disease Control and
20	Prevention and the World Health Organization as a fast-growing epidemic that can all too
21	easily lead to overdose and death; and
22	WHEREAS, For every drug overdose that results in death, there are many more
23	nonfatal overdoses, each taking an emotional and economic toll on the individual, the

individual's family, and the community at large; and



- WHEREAS, Drug addiction can fuel feelings of shame, guilt, embarrassment, depression, and hopelessness, causing individuals to resist seeking treatment and support; and
- WHEREAS, Overdose Awareness Day is a global event held on August 31 each year that aims to raise awareness of drug overdoses, reduce the stigma of a drug—related death, and acknowledge the grief felt by families and friends remembering those who have died or had a permanent injury as a result of a drug overdose; and
- WHEREAS, Recognizing Overdose Awareness Day in Maryland sends a strong message to former or current substance users, namely, that they are valued, and that overdose death is preventable; now, therefore,
- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That Section(s) 7–415 through 7–418 of Article – General Provisions of the Annotated Code of Maryland be renumbered to be Section(s) 7–416 through 7–419, respectively.
- SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read as follows:
- 16 Article General Provisions
- 17 **7–415.**
- THE GOVERNOR ANNUALLY SHALL PROCLAIM AUGUST 31 AS OVERDOSE AWARENESS DAY.
- SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2023.
