 veteran at a State veterans' cemetery; and generally relating to State veterans'

8 (b) The Department may establish one or more cemeteries in the State for the 9 burial of veterans and their eligible spouse or dependents as authorized by the Secretary.

10 (c) The Department may accept land, on behalf of the State or a political 11 subdivision of the State, or otherwise acquire land for a State veterans' cemetery, if the 12 Department has the approval of:

(1) the governing body of the county where the State veterans' cemetery isto be located;
