2 **Calvert County – Length of Service Award Program – Benefits**

3 FOR the purpose of altering a certain benefit amount for certain fire and rescue volunteers;
4 authorizing the Calvert County Board of County Commissioners to approve an
5 increase in benefit payment for certain volunteers; and generally relating to the
6 Length of Service Award Program.

3 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
4 That the Laws of Maryland read as follows:

5 **Article 5 – Calvert County**

6 14–102.

7 (a) Any individual who has served as a member of any Calvert County volunteer
8 fire company, Calvert County volunteer rescue squad, or Calvert County rescue dive team
9 is eligible to receive the following benefits, provided that:

10 (1) The individual is certified in accordance with the provisions of § 14–101
11 of this subtitle to have served as an active volunteer subsequent to January 1, 1986.

12 (2) Any individual who discontinued active volunteer service prior to
13 January 1, 1986, may receive credit for the service after being certified in accordance with
14 the provisions of § 14–104(b) of this subtitle.

15 (g) (1) In the event a qualified volunteer who has completed 25 years of
16 certified service dies, a [burial] **DEATH** benefit up to [\$6,000] **\$10,000** shall be payable.

17 (2) In the event a volunteer who is receiving benefits under Subsection (h)
18 of this section dies, a burial benefit up to [\$240] **\$336** for each year of certified service shall
19 be payable.

20 (h) In the event that any active volunteer fireman, squad member, or rescue dive
21 team member (defined as an individual who has at least two years of qualifying service in
22 the five preceding years) attains the age of 70 years and fails to achieve the required 25
23 years of service, the volunteer is entitled to a monthly benefit of the number of years of
24 certified service completed multiplied by \$8. These benefits shall be payable in the normal
25 manner.

26 (i) In addition to any other benefit provided under this section, in the event that
27 a qualified volunteer dies in the line of duty, as determined by the State Workers'
28 Compensation Commission, the qualified volunteer is eligible to receive a death benefit of
29 [\$6,000] **\$10,000**.

30 **(J) THE BOARD OF COMMISSIONERS MAY APPROVE AN INCREASE IN THE**
31 **BENEFIT AMOUNT THAT A QUALIFIED VOLUNTEER IS ELIGIBLE TO RECEIVE THAT**
32 **CORRESPONDS TO THE PERCENTAGE OF THE COST-OF-LIVING INCREASE**
33 **AUTHORIZED FOR COUNTY EMPLOYEES.**

34 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July

1 1, 2023.
