BY repealing and reenacting, without amendments, Article – Education Section 3–108.1(c) and (n) Annotated Code of Maryland (2022 Replacement Volume) BY repealing and reenacting, with amendments, Article – Education Section 3–108.1(d) and (m) Annotated Code of Maryland (2022 Replacement Volume) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:
