## A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Developmental Disabilities Council – Establishment**

3 FOR the purpose of establishing the Maryland Developmental Disabilities Council as an  
4 independent unit of State government; and generally relating to the Maryland  
5 Developmental Disabilities Council.

6 BY adding to

7 Article – Health – General

8 Section 7–12A–01 through 7–12A–04 to be under the new subtitle “Subtitle 12A.

9 Maryland Developmental Disabilities Council”

10 Annotated Code of Maryland

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
13 That the Laws of Maryland read as follows:

14 **Article – Health – General**

15 **SUBTITLE 12A. MARYLAND DEVELOPMENTAL DISABILITIES COUNCIL.**

16 **7–12A–01.**

17 **(A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS**  
18 **INDICATED.**

19 **(B) “ACT” MEANS THE FEDERAL DEVELOPMENTAL DISABILITIES**  
20 **ASSISTANCE AND BILL OF RIGHTS ACT OF 2000.**

21 **(C) “COUNCIL” MEANS THE MARYLAND DEVELOPMENTAL DISABILITIES**  
22 **COUNCIL.**

1 (D) "STATE PLAN" MEANS THE STRATEGIC PLAN DEVELOPED UNDER §  
2 7-12A-02(E) OF THIS SUBTITLE.

3 7-12A-02.

4 (A) THERE IS A MARYLAND DEVELOPMENTAL DISABILITIES COUNCIL.

5 (B) THE COUNCIL IS AN INDEPENDENT UNIT OF STATE GOVERNMENT.

6 (C) THE COUNCIL OPERATES AND RECEIVES FUNDING IN ACCORDANCE  
7 WITH THE ACT.

8 (D) THE COUNCIL HAS THE AUTHORITY TO:

9 (1) CONDUCT AND SUPPORT ADVOCACY, SYSTEMS CHANGE, AND  
10 CAPACITY-BUILDING EFFORTS TO PROMOTE INCLUSIVE COMMUNITIES AND EQUITY  
11 IN SERVICES FOR INDIVIDUALS WITH DISABILITIES IN THE STATE;

12 (2) RESEARCH BEST PRACTICES AND PROVIDE RELATED TRAINING  
13 AND TECHNICAL ASSISTANCE TO COMMUNITIES IN THE STATE; AND

14 (3) INFORM STATE AND LOCAL LEADERS ABOUT DISABILITY ISSUES.

15 (E) THE COUNCIL SHALL:

16 (1) DEVELOP AND IMPLEMENT A 5-YEAR STRATEGIC PLAN IN  
17 ACCORDANCE WITH THE ACT;

18 (2) MONITOR, REVIEW, AND ANNUALLY EVALUATE THE  
19 IMPLEMENTATION OF THE STATE PLAN;

20 (3) TO THE EXTENT PRACTICABLE, REVIEW ANY PLAN IN THE STATE  
21 THAT RELATES TO PROGRAMS AFFECTING INDIVIDUALS WITH DEVELOPMENTAL  
22 DISABILITIES;

23 (4) ON REQUEST, SUBMIT TO THE SECRETARY OF THE FEDERAL  
24 DEPARTMENT OF HEALTH AND HUMAN SERVICES PERIODIC REPORTS ON ITS  
25 ACTIVITIES;

26 (5) SERVE AS AN ADVOCATE FOR INDIVIDUALS WITH  
27 DEVELOPMENTAL DISABILITIES;

1           **(6) CONDUCT OR SUPPORT PROGRAMS, PROJECTS, AND ACTIVITIES**  
2 **THAT CARRY OUT THE PURPOSE OF THE ACT;**

3           **(7) ADVISE THE GOVERNOR, THE GENERAL ASSEMBLY, STATE**  
4 **AGENCIES, AND OTHER RELEVANT ORGANIZATIONS ON POLICIES, PROGRAMS, AND**  
5 **ISSUES RELATED TO THE NEEDS OF INDIVIDUALS WITH DEVELOPMENTAL**  
6 **DISABILITIES AND THEIR FAMILIES; AND**

7           **(8) REVIEW AND MAKE FINDINGS AND RECOMMENDATIONS**  
8 **REGARDING PROGRAMS RELATED TO THE SUPPORT AND SERVICES PROVIDED TO**  
9 **INDIVIDUALS WITH DEVELOPMENTAL DISABILITIES AND THEIR FAMILIES.**

10          **(F) A STATE ENTITY MAY NOT INTERFERE WITH THE COUNCIL'S ADVOCACY,**  
11 **CAPACITY BUILDING, SYSTEMIC CHANGE ACTIVITIES, BUDGET, PERSONNEL, OR**  
12 **STATE PLAN DEVELOPMENT OR IMPLEMENTATION.**

13 **7-12A-03.**

14          **(A) THE COUNCIL SHALL HIRE AN EXECUTIVE DIRECTOR.**

15          **(B) THE EXECUTIVE DIRECTOR MAY EMPLOY ADDITIONAL STAFF**  
16 **NECESSARY TO CARRY OUT THE COUNCIL'S FUNCTIONS.**

17          **(C) THE EXECUTIVE DIRECTOR SHALL DETERMINE THE ORGANIZATIONAL**  
18 **STRUCTURE AND PHYSICAL LOCATION OF COUNCIL STAFF.**

19 **7-12A-04.**

20          **(A) MEMBERS OF THE COUNCIL SHALL COMPLY WITH THE REQUIREMENTS**  
21 **OF THE ACT.**

22          **(B) THE COUNCIL CONSISTS OF THE FOLLOWING MEMBERS, APPOINTED BY**  
23 **THE GOVERNOR:**

24               **(1) THE STATE SUPERINTENDENT OF SCHOOLS, OR THE**  
25 **SUPERINTENDENT'S DESIGNEE;**

26               **(2) THE ASSISTANT STATE SUPERINTENDENT OF THE DIVISION OF**  
27 **REHABILITATION SERVICES, OR THE ASSISTANT STATE SUPERINTENDENT'S**  
28 **DESIGNEE;**

29               **(3) THE SECRETARY OF DISABILITIES, OR THE SECRETARY'S**  
30 **DESIGNEE;**

1           **(4) THE DEPUTY SECRETARY OF THE DEVELOPMENTAL**  
2 **DISABILITIES ADMINISTRATION, OR THE DEPUTY SECRETARY'S DESIGNEE;**

3           **(5) THE SECRETARY OF AGING, OR THE SECRETARY'S DESIGNEE;**

4           **(6) ONE REPRESENTATIVE OF THE MARYLAND CENTER FOR**  
5 **DEVELOPMENTAL DISABILITIES;**

6           **(7) ONE REPRESENTATIVE OF DISABILITY RIGHTS MARYLAND;**

7           **(8) ONE REPRESENTATIVE OF THE PREVENTION AND HEALTH**  
8 **PROMOTION ADMINISTRATION OR ANY OTHER STATE ENTITY AUTHORIZED TO**  
9 **ADMINISTER FUNDS PROVIDED UNDER TITLE V OF THE FEDERAL SOCIAL SECURITY**  
10 **ACT;**

11           **(9) ONE REPRESENTATIVE OF THE MARYLAND MEDICAL**  
12 **ASSISTANCE PROGRAM OR ANY OTHER STATE ENTITY AUTHORIZED TO ADMINISTER**  
13 **FUNDS PROVIDED UNDER TITLE XIX OF THE FEDERAL SOCIAL SECURITY ACT;**

14           **(10) ONE REPRESENTATIVE OF A LOCAL NONGOVERNMENTAL**  
15 **AGENCY;**

16           **(11) ONE REPRESENTATIVE OF A PRIVATE NONPROFIT ORGANIZATION**  
17 **THAT PROVIDES SERVICES FOR INDIVIDUALS WITH DEVELOPMENTAL DISABILITIES**  
18 **IN THE STATE; AND**

19           **(12) ANY ADDITIONAL INDIVIDUALS NECESSARY TO MEET THE**  
20 **REQUIREMENTS OF SUBSECTION (C) OF THIS SECTION AND THE ACT.**

21           **(c) (1) AT LEAST 60% OF THE MEMBERS OF THE COUNCIL MUST BE:**

22                   **(i) INDIVIDUALS WITH DEVELOPMENTAL DISABILITIES;**

23                   **(ii) PARENTS OR GUARDIANS OF CHILDREN WITH**  
24 **DEVELOPMENTAL DISABILITIES; OR**

25                   **(iii) IMMEDIATE RELATIVES OR GUARDIANS OF ADULTS WITH**  
26 **DEVELOPMENTAL DISABILITIES WHO CANNOT ADVOCATE FOR THEMSELVES.**

27           **(2) IN ADDITION TO THE REQUIREMENTS UNDER PARAGRAPH (1) OF**  
28 **THIS SUBSECTION:**

1                   **(I) AT LEAST ONE-THIRD OF THE MEMBERS MUST BE**  
2 **INDIVIDUALS WITH DEVELOPMENTAL DISABILITIES;**

3                   **(II) AT LEAST ONE-THIRD OF THE MEMBERS MUST BE PARENTS**  
4 **OR GUARDIANS OF CHILDREN WITH DEVELOPMENTAL DISABILITIES OR GUARDIANS**  
5 **OR IMMEDIATE RELATIVES OF ADULTS WITH DEVELOPMENTAL DISABILITIES WHO**  
6 **CANNOT ADVOCATE FOR THEMSELVES; AND**

7                   **(III) AT LEAST ONE MEMBER MUST BE:**

8                   **1. AN INDIVIDUAL WITH A DEVELOPMENTAL DISABILITY**  
9 **WHO RESIDES OR PREVIOUSLY RESIDED IN AN INSTITUTION; OR**

10                   **2. AN IMMEDIATE RELATIVE OR GUARDIAN OF AN**  
11 **INDIVIDUAL WITH A DEVELOPMENTAL DISABILITY WHO RESIDES OR PREVIOUSLY**  
12 **RESIDED IN AN INSTITUTION.**

13                   **(D) THE MEMBERSHIP OF THE COUNCIL SHALL BE GEOGRAPHICALLY**  
14 **REPRESENTATIVE OF THE STATE AND REFLECT THE DIVERSITY OF THE STATE WITH**  
15 **RESPECT TO RACE AND ETHNICITY.**

16                   **(E) THE COUNCIL SHALL ELECT A CHAIR AND VICE CHAIR FROM AMONG ITS**  
17 **MEMBERS.**

18                   **(F) THE COUNCIL SHALL ADOPT BYLAWS, POLICIES, AND OPERATING**  
19 **PROCEDURES THAT ARE IN COMPLIANCE WITH THE ACT AND WITH STATE LAW.**

20                   SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
21 1, 2023.
