#### 1 AN ACT concerning

# Green and Renewable Energy for Nonprofit Organizations Loan Program and Fund

FOR the purpose of establishing the Green and Renewable Energy for Nonprofit 4  $\mathbf{5}$ Organizations Loan Program in the Maryland Energy Administration to provide 6 financial assistance to nonprofit organizations for the purchase and installation of 7 qualifying energy systems and technical assistance for the planning and installation 8 of qualifying energy systems; establishing the Green and Renewable Energy for 9 Nonprofit Organizations Loan Fund as a special, nonlapsing fund; requiring interest earnings of the Fund to be paid into the Fund; requiring the Administration, on or 10 11 before a certain date, to establish an application process, set guidelines and 12considerations for application, selection, and repayment for loans made under the 13 Program, and develop an advertising campaign for the Program; and generally 14 relating to the Green and Renewable Energy for Nonprofit Organizations Loan 15Program and Fund.

14(2) ADOPT REGULATIONS TO ENSURE THAT LOANS PROVIDED TO15NONPROFIT ORGANIZATIONS CARRY OUT THE PURPOSE OF THE PROGRAM; AND

16(3) ATTACH SPECIFIC TERMS TO ANY LOAN THAT ARE CONSIDERED17NECESSARY TO ENSURE THAT THE PURPOSE OF THE PROGRAM IS FULFILLED.

19 (A) (1) TO RECEIVE A LOAN UNDER THE PROGRAM, A BORROWER MUST 20 FILE AN APPLICATION WITH THE ADMINISTRATION.

21(2)THE APPLICATION MUST BE SIGNED BY THE CHIEF OPERATING22OFFICER OR AN AUTHORIZED OFFICER OF THE NONPROFIT ORGANIZATION.

23 **(B)** THE APPLICATION MUST CONTAIN ANY INFORMATION THE 24 ADMINISTRATION DETERMINES IS NECESSARY, INCLUDING:

25(1) THE PROJECTED COST OF THE QUALIFYING ENERGY SYSTEM OR26TECHNICAL ASSISTANCE BEING FINANCED THROUGH THE LOAN;

27(2)THE LOCATION OF THE PROPERTY WHERE THE QUALIFYING28ENERGY SYSTEM WILL BE INSTALLED AND WHETHER THE PROPERTY IS OWNED OR

## 1 LEASED BY THE APPLICANT; AND

2 (3) ANY ADDITIONAL INFORMATION RELATING TO THE BORROWER OR 3 THE PROPOSED QUALIFYING ENERGY SYSTEM BEING FINANCED THROUGH THE 4 LOAN THAT MAY BE REQUIRED BY THE ADMINISTRATION IN ORDER TO ADMINISTER 5 THE PROGRAM.

6 (C) THE ADMINISTRATION MAY APPROVE AN APPLICATION FOR A LOAN 7 UNDER § 9–2106(A)(1) OF THIS SUBTITLE ONLY IF THE APPLICATION 8 DEMONSTRATES THAT THE PROPOSED QUALIFYING ENERGY SYSTEM IS ESTIMATED, 9 BASED ON PROJECTED ENERGY COSTS, TO GENERATE ENERGY COST SAVINGS OVER 10 THE USEFUL LIFE OF THE SYSTEM THAT EQUAL OR EXCEED THE TOTAL AMORTIZED 11 COST OF THE LOAN.

12 (D) IN APPROVING AN APPLICATION, THE ADMINISTRATION SHALL 13 CONSIDER AND GIVE PRIORITY TO AN APPLICANT THAT HAS AN ANNUAL BUDGET OF 14 \$1,000,000 OR LESS.

22 (B) EACH BORROWER FOR A LOAN UNDER SUBSECTION (A)(1) OF THIS 23 SECTION SHALL CONTRIBUTE AT LEAST 10% OF THE COST OF THE QUALIFYING 24 ENERGY SYSTEM.

(C) LOANS MADE UNDER THE PROGRAM SHALL BE REPAYABLE BY THE
BORROWER IN ACCORDANCE WITH A SCHEDULE THAT THE ADMINISTRATION SETS,
WHICH MAY BE ON A DEFERRED PAYMENT BASIS.

28 (D) (1) A BORROWER SHALL PROVIDE ASSURANCES FOR THE 29 REPAYMENT OF A LOAN.

- 31 (I) SHALL INCLUDE A PROMISSORY NOTE; AND

6 (A) THERE IS A GREEN AND RENEWABLE ENERGY FOR NONPROFIT 7 ORGANIZATIONS LOAN FUND.

8 (B) THE ADMINISTRATION SHALL ADMINISTER THE FUND.

9 (C) (1) THE FUND IS A SPECIAL, NONLAPSING FUND THAT IS NOT 10 SUBJECT TO § 7–302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.

11 (2) THE STATE TREASURER SHALL HOLD THE FUND SEPARATELY, 12 AND THE COMPTROLLER SHALL ACCOUNT FOR THE FUND.

- 13 (D) THE FUND CONSISTS OF:
- 14 (1) MONEY APPROPRIATED IN THE STATE BUDGET TO THE PROGRAM;
- 15 (2) MONEY RECEIVED FROM ANY PUBLIC OR PRIVATE SOURCE;
- 16 (3) INTEREST AND INVESTMENT EARNINGS OF THE FUND; AND

17(4) REPAYMENTS AND PREPAYMENTS ON LOANS MADE FROM THE18FUND.

19 (E) (1) IN FISCAL YEAR 2025, THE GOVERNOR SHALL INCLUDE IN THE 20 ANNUAL BUDGET BILL AN APPROPRIATION OF \$5,000,000 FOR THE FUND.

(2) IN FISCAL YEAR 2026, THE GOVERNOR SHALL INCLUDE IN THE
 ANNUAL BUDGET BILL AN APPROPRIATION EQUAL TO AT LEAST \$5,000,000 MINUS
 THE AMOUNT IN THE FUND AS OF JUNE 30 OF THE IMMEDIATELY PRECEDING
 FISCAL YEAR.

6 (2) ANY INVESTMENT EARNINGS OF THE FUND SHALL BE PAID INTO 7 THE FUND.

8 (3) ANY REPAYMENT ON LOANS MADE FROM THE FUND SHALL BE 9 PAID INTO THE FUND.

12 (a) (2) (i) Notwithstanding any other provision of law, and unless 13 inconsistent with a federal law, grant agreement, or other federal requirement or with the 14 terms of a gift or settlement agreement, net interest on all State money allocated by the 15 State Treasurer under this section to special funds or accounts, and otherwise entitled to 16 receive interest earnings, as accounted for by the Comptroller, shall accrue to the General 17 Fund of the State.

18 (ii) The provisions of subparagraph (i) of this paragraph do not apply19 to the following funds:

20 170. the Cannabis Public Health Fund; [and]

SECTION 2. AND BE IT FURTHER ENACTED, That, on or before July 1, 2024, the
 Maryland Energy Administration shall:

(1) establish an application process for loans made under the Green and
Renewable Energy for Nonprofit Organizations Loan Program in Title 9, Subtitle 21 of the
State Government Article, as enacted by Section 1 of this Act;

29 (2) set guidelines and considerations for application, selection, and 30 repayment that include:

(i) nonprofit organizations that own, rather than rent, their

- 2 (ii) property size and kilowatt–hours of energy used;
- 3 (iii) geographic diversity;
- 4 (iv) ethnic and racial diversity;
- 5 (v) economic diversity;
- 6 (vi) nonprofit organization mission diversity;
- 7 (vii) access to the borrower's portion of the cost of the qualifying 8 energy system; and

(viii) process and frequency of loan repayment; and

10 (3) develop and implement an advertising campaign for the Green and 11 Renewable Energy for Nonprofit Organizations Loan Program.

12 SECTION 3. AND BE IT FURTHER ENACTED, That Section 1 of this Act shall take 13 effect July 1, 2024.

SECTION 4. AND BE IT FURTHER ENACTED, That, except as provided in Section
 3 of this Act, this Act shall take effect July 1, 2023.
