# Income Tax Checkoff – Maryland Veterans Trust Fund

FOR the purpose of establishing a certain income tax checkoff for voluntary contributions
to the Maryland Veterans Trust Fund; requiring the Comptroller to include a
checkoff on individual income tax return forms for voluntary contributions to the
Fund and to include certain information in each individual income tax return
package; and generally relating to an income tax checkoff for contributions to the
Maryland Veterans Trust Fund.
